

METHODOLOGICAL NOTES

1. The **data source** is the Statistical Business Register managed by the Romanian NIS, in accordance with Regulation (EC) No 177/2008 of the European Parliament and of the Council of 20 February 2008 establishing a common framework for business registers for statistical purposes and repealing Council Regulation (EEC) No 2186/93. For this statistical unit (the enterprise group), the updating of the Statistical Business Register is done based on the following sources:

- the National Trade Register Office managed by the Ministry of Justice;
- the annual statistical survey on financial links between enterprises;
- the European Register of Multinational Enterprise Groups, managed by Eurostat.

The data for 2018 are not comparable to those of previous years both due to changes in the methodology for the management of the companies controlled by foreign legal/natural persons, developed as a result of the improved use of the administrative (national and international) data sources, and to the changes in the national and/or European legislation (e.g. Regulation (EU) No 679/2016 of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data and on the free movement of such data – GDPR).

2. Definition:

Legal unit	any economic or social operator having its own patrimony; it can conclude contracts with third parties in its own name and defend its interests in a court of law - it has legal personality. Legal units are either authorised natural persons, individual enterprises, family enterprises (acting as entrepreneurs) or legal persons;
Control	a legal unit is controlled if another legal unit holds a percentage strictly exceeding 50% in the decision-making process in the general meeting of shareholders or contractually has the right to control;
Group	several enterprises linked to a group head through a non-zero real control rate;
Group head	a legal unit that is not controlled, directly or indirectly, by another legal unit and that controls at least one subsidiary;
Multinational enterprise group	a group of enterprises comprising at least two legal units located in different countries;
Subgroup of enterprises	legal units (enterprises) of a multinational enterprise group that are resident in the same country;
All-resident enterprise group	an enterprise group whose legal units (enterprises) are all resident in the same country.
