Employment of disabled people

Labour Force Survey ad hoc module - the second quarter of 2011 addressed to persons aged 15-64 years

For a correct interpretation of results, please see the Methodological notes on page 4 of this Press Release

Almost two thirds of people with longstanding health problems or functional limitations faced one or more restrictions in working activities.

The employment rate of disabled people in the second quarter of 2011 was 23.9%, much lower than the one for people without disabilities (64.8%).

The unemployment rate for people with disabilities was in the second quarter of 2011 9.1%, 1.7 p.p higher than the value recorded for people without disabilities.

30.1% of employed persons with disabilities received one or more types of special assistance in order to help them to work. Almost two thirds (64.0%) of people with disabilities, not in employment (unemployed or inactive persons), would need one or more special support measures in order to be able to work.

In the second quarter of 2011, out of the *14622 thou. persons in the target population of the survey*, 63.0% belonged to age group 25-54 years, 58.5% lived in urban area and 50.4% were women. Of these, *2703 thou. persons* - representing 18.5% - *had, according their own statements, longstanding health problems or functional limitations* - sensory, physical or mental (measured by the difficulty to perform some basic activities).

Limitations in working activities

Out of the total number of 2703 thou. persons with health problems or functional limitations, 1693 thou. (62.6%) were limited in one or several ways in working activities; these limitations refers to:

- type of work they could do;
- number of hours they could work;
- transportation to and from work;

while for the remaining persons, the existence of health problems or functional limitations had no impact on working life.

These people, whose professional activity is limited in one or several ways because of health problems or functional limitations, will be referred to as "persons with disabilities in employment."

Persons 45 years and over accounted for 83.1% of the population with disabilities in employment, while young people aged 15-24 accounts for only 2.6%. In comparison, non-disabled population¹ had a more balanced distribution on age groups, with slightly higher values in the range of age groups 25-44 years.




Figure 1 – Disabled and non-disabled population by age groups

Given the cause of working limitation, it may be noticed that, out of the 1693 thou. persons with disabilities in employment:

- > 1041 thou. people (61.5%) were limited in work due to both, health problems and functional limitations
- for 575 thou. people (representing just over one third 34.0%) health problems were the exclusive cause of work limitations;
- > 76 thou. people (4.6%) stated as the cause of restrictions in work, exclusively functional limitations.

Participation in economic activity of persons with disabilities in employment

Out of the 1693 thou persons with disabilities in employment, **405 thou.** were employed while **40 thou.** were **ILO unemployed**. Almost three quarters (73.7%) were not-economically active persons.

The employment rate of disabled people was, in the second quarter of 2011, 23.9%, much lower than the one for non-disabled persons (64.8%).




Figure 2 – Employment rate of disabled and non-disabled people

The unemployment rate for people with disabilities was, in the second quarter 2011, 9.1%, 1.7 p.p. higher the value recorded for people without disabilities. The largest difference between the two rates may be noticed for young people aged 15-24 (44.6% for young people with disabilities as compared to 21.7% for those without disabilities).




Figure 3 - Unemployment rate for disabled and non-disabled people

Out of the 1247 thou non-economically active persons with disabilities, 64.1% were aged 55 - 64 years, 60.2% were women and 65.1% lived in urban areas.

Special assistance for people with disabilities

Out of the 405 thou employed persons with disabilities, only 122 thou. (representing 30.1%) actually received at the workplace one or more types of special assistance in order to help them work. They benefited of²:

- personal assistance, in the sense of help / support in work 22.4% of employed persons with disabilities;
- special equipments or workplace adaptations 2.9% of employed persons with disabilities;
- ➤ special working arrangements (sedentary work, working at home, flexible hours of work, etc.) 14.4% of employed persons with disabilities.

Almost two thirds (64.0%) of the 1287 thou persons with disabilities, not in employment (unemployed or inactive persons) declared that they would need one or more special support measures in order to be able to work:

- 43.4% would need personal assistance
- ➤ 28.9% would need special equipments workplace adaptations
- > 59.0% would need special working arrangements.

METHODOLOGICAL NOTES

- 1. The data source is the ad-hoc module "Employment of disabled people" attached to the Household Labour Force Survey in the second quarter of 2011. The main objective of the module is to offer information on the situation of disabled people on the labour market and compare it to the one for non-disabled.
- 2. Employment comprises all persons aged 15 years and over who carried out an economic activity producing goods or services of at least one hour3 during the reference period (one week), in order to get income as salary, payment in kind or other benefits. Beginning with 2011, self-employed and contributing family workers from agriculture are considered as employed persons only if they are the owners of agricultural production (not necessarily of lands) achieved and they meet one of the following conditions:
 - The agricultural production is intended, even partially, to sale or to barter agreements;
 - The agricultural production is exclusively intended to self-consumption if it accounts for a significant part4 of household's total consumption.

Employment is not comprising the persons who:

- Carry out minor agricultural activities5, for recreation, hobby or in view to obtain, additionally, food goods which do not represent a significant part of household's total consumption;
- Carry out agricultural activities (whose duration exceeds 10 hours/weekly), the agricultural production being exclusively intended for self-consumption, but it does not represent a significant part of household's total consumption.
- 3. **Employment rate** represents the weight of employed persons of age group x in total population of the same age group x.
- 4. **ILO**¹⁾ **unemployed** are **persons** aged 15-74 years old who in the reference period fulfill the following conditions: (i) have no job and do not carry out an activity in order to get income; (ii) are looking for a job, in the last 4 weeks; are available to start work in the next two weeks.
- 5. **ILO unemployment rate** represents the ratio of ILO unemployed of age group x in economically active population of age group x.
- 6. Longstanding heath problems refers to health condition or disease that has lasted or are likely to last for at least 6 months. The main characteristic of la longstanding heath problem is that it is permanent and generally, require a long period of time for supervision, observation and treatment.
- 7. **Functional limitations** physical sensory or mental were identified by a set of questions related to difficulties in performing certain basic activities. Thus, there has been tested to the difficulties, in seeing, hearing, walking and climbing, mobility, difficulties in changing posture, lifting, transporting and handling objects, memory difficulties, concentration and communication.
- 8. Persons disabled in employment are persons having longstanding health problems or functional limitations which impose person's limitation work. Types of work limitations are:
 - type of work they can do;
 - number of hours they can work;
 - transportation to and from work.

The new concept of disability, as it is defined by International Classification of Functioning, Disability and Health (biopsychosocial concept) was implemented in the survey in a restricted form due to the limited number of questions. For this reason, the aim of the module is not to measure the prevalence of disability in the population.
