

## THE RETAIL TURNOVER INCREASED BY 12.0%

- As against the previous month, in September 2015 the retail turnover volume (excluding the trade with motor vehicles and motorcycles) decreased as gross series by 0.6% and increased as adjusted series according to the number of working days and to seasonality by 1.7%.
- As against the corresponding month of the previous year, the retail turnover volume (excluding the trade with motor vehicles and motorcycles) increased both as gross series and as adjusted series according to the number of working days and to seasonality by 12.0% and by 10.9%, respectively.
- As against the period 1.I 30.IX.2014, in the period 1.I 30.IX.2015 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), increased both as gross series and as adjusted series according to the number of working days and to seasonality by 6.9% and by 6.4%, respectively.

#### September 2015 as against August 2015

As against the previous month, in September 2015 the retail turnover volume (excluding the trade with motor vehicles and motor cycles), gross series, globally decreased by 0.6% due to the drops registered by the sale of food, beverages and tobacco (-5.1%) and by retail of automotive fuel in specialised stores (-3.9%). The sale of non-food products increased by 5.5%.

As against the previous month, in September 2015 the retail turnover volume (excluding the trade with motor vehicles and motor cycles), adjusted series according to the number of working days and to seasonality, globally increased by 1.7% due to the increments registered by the sale of non-food products (+2.7%), by the sale of food, beverages and tobacco (+1.2%) and by the retail of automotive fuel in specialised stores (+0.7%).

#### September 2015 as against September 2014

As against September 2014, in September 2015 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), gross series, registered an increase of 12.0% due to the increments registered by the sale of food, beverages and tobacco (+27.6%), by the sale of non-food products (+5.2%) and by the retail of automotive fuel in specialised stores (+4.6%).

As against September 2014, in September 2015 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), adjusted series according to the number of working days and to seasonality, registered an increase of 10.9% due to the increments registered by the sale of food, beverages and tobacco (+27.3%), by the retail of automotive fuel in specialised stores (+5.2%) and by the sale of non-food products (+3.8%).

#### Period 1.I - 30.IX.2015 as against period 1.I - 30.IX.2014

As against the period 1.I - 30.IX.2014, in the period 1.I - 30.IX.2015 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), gross series, registered an increase of 6.9% due to the increments registered by the sale of food, beverages and tobacco (+16.3%), by the retail of automotive fuel in specialised stores (+5.4%) and by the sale of non-food products (+0.6%).

As against the period 1.I - 30.IX.2014, in the period 1.I - 30.IX.2015 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), adjusted series according to the number of working days and to seasonality, registered an increase of 6.4% due to the increments registered by the sale of food, beverages and tobacco (+15.4%), by the retail of automotive fuel in specialised stores (+5.0%) and by the sale of non-food products (+0.8%).
