THE WHOLESALE TURNOVER INCREASED IN 2015 BY 4.1%

- As against the previous month, in December 2015 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, in nominal terms, increased both as gross series by **1.7%** and as adjusted series according to the number of working days and to seasonality by **1.8%**.
- As against the corresponding month of the previous year, **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, in nominal terms, increased both as gross series by **11.7%** and as adjusted series according to the number of working days and to seasonality by **10.1%**.
- As against 2014, in 2015 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, in nominal terms, increased as gross series by **4.1%**.

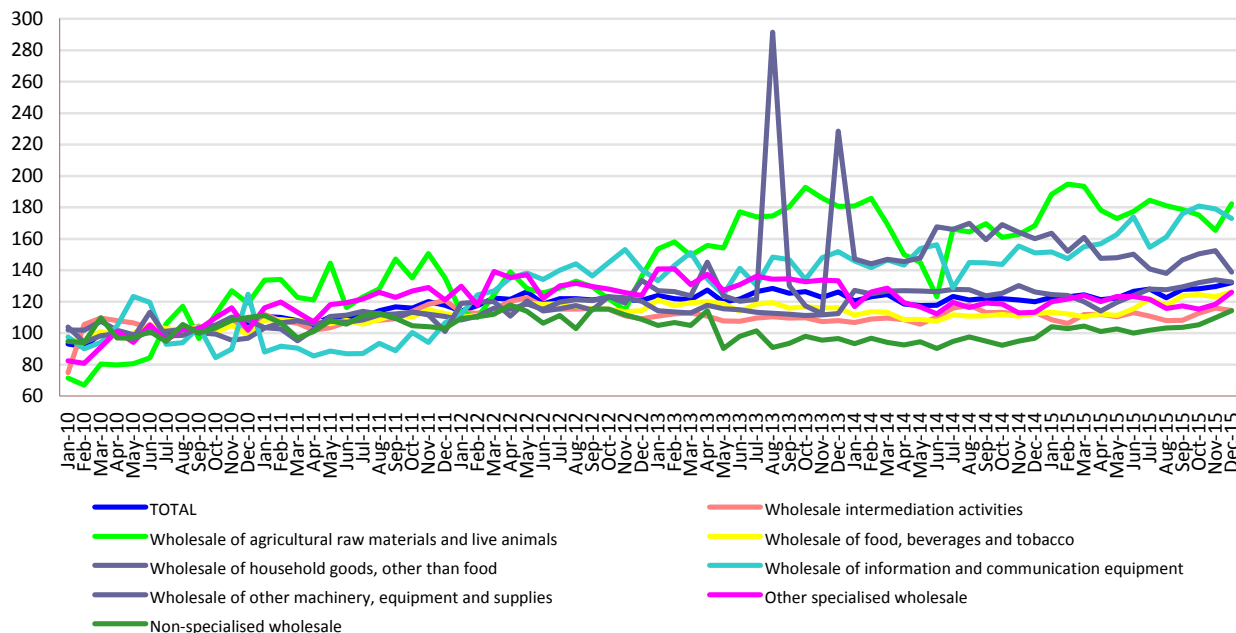

December 2015 as against November 2015

As against the previous month, in December 2015 the **wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, gross series, in nominal terms, globally increased by 1.7% due to the increments registered by the wholesale of agricultural raw materials and live animals (+13.6%) and by the wholesale of food, beverages and tobacco (+12.6%). Drops were registered by the other specialised wholesale (-9.9%), by the wholesale intermediation activities (-2.3%), by the wholesale of household goods, other than food (-1.3%), by the non-specialised wholesale (-1.0%), by the wholesale of information and communication equipment (-0.5%) and by the wholesale of other machinery, equipment and supplies (-0.1%).

As against the previous month, in December 2015 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, adjusted series according to the number of working days and to seasonality, in nominal terms, globally increased by 1.8% due to the increments registered by the wholesale of agricultural raw materials and live animals (+10.2%), by the other specialised wholesale (+6.4%), by the non-specialised wholesale (+4.1%) and by the wholesale of food, beverages and tobacco (+2.4%). Drops were registered by the wholesale of other machinery, equipment and supplies (-9.0%), by the wholesale of information and communication equipment (-3.4%), by the wholesale intermediation activities (-1.2%) and by the wholesale of household goods, other than food (-1.1%).

December 2015 as against December 2014

As against December 2014, in December 2015 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, gross series, in nominal terms, registered an increase of 11.7% due to the increments registered by the wholesale of information and communication equipment (+31.3%), by the non-specialised wholesale (+24.1%), by the other specialised wholesale (+14.0%), by the wholesale of agricultural raw materials and live animals (+13.5%), by the wholesale of food, beverages and tobacco (+13.2%), by the wholesale of household goods, other than food (+7.7%) and by the wholesale intermediation activities (+2.4%). The wholesale of other machinery, equipment and supplies decreased by 10.6%.

As against December 2014, in December 2015 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, adjusted series according to the number of working days and to seasonality, in nominal terms, registered an increase of 10.1% due to the increments registered by the non-specialised wholesale (+18.0%), by the wholesale of information and communication equipment (+14.5%), by the wholesale of food, beverages and tobacco (+12.1%), by the other specialised wholesale (+11.3%), by the wholesale of agricultural raw materials and live animals (+8.3%), by the wholesale of household goods, other than food (+5.0%) and by the wholesale intermediation activities (+1.0%). Drops were registered by the wholesale of other machinery, equipment and supplies (-13.4%).

Year 2015 as against 2014

As against 2014, in 2015 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, gross series, in nominal terms, registered an increase of 4.1% due to the increments registered by the wholesale of information and communication equipment (+17.4%), by the non-specialised wholesale (+13.5%), by the wholesale of agricultural raw materials and live animals (+12.1%), by the wholesale of food, beverages and tobacco (+6.5%) and by the other specialised wholesale (+1.4%). Drops were registered by the wholesale of other machinery, equipment and supplies (-7.0%), by the wholesale intermediation activities (-1.5%) and by the wholesale of household goods, other than food (-0.3%).
