


Domain: International trade with goods

In the year 2015, the exports and imports increased by 4.1% and by 7.6%, respectively, compared to the year 2014

- In the year 2015, the FOB exports amounted to 54597.1 million euro and the CIF imports amounted to 62965.5 million euro.
- In the year 2015, the FOB-CIF commercial deficit was of 8368.4 million euro, 2305.6 million euro more than in the year 2014.
- In December 2015, the FOB exports were of 3942.2 million euro and the CIF imports were of 5117.1 million euro, a commercial deficit of 1174.9 million euro being registered.
- Compared to November 2015, the exports decreased by 17.0% and the imports decreased by 7.5% in December 2015.

Exports, imports and FOB/CIF balance during January 2010 – December 2015



In the year 2015, the Intra-community trade of goods (Intra-EU28) amounted to 40240.8 million euro for dispatches and to 48584.9 million euro for arrivals, representing 73.7% of the total exports and 77.2% of the total imports.


In the year 2015, the Extra-community trade of goods (Extra-EU28) amounted to 14356.3 million euro for exports and to 14380.6 million euro for imports, representing 26.3% of the total exports and 22.8% of the total imports.

INTRA – EU28 and EXTRA – EU28 exports during January 2013 – December 2015






FOB-CIF balance for INTRA – EU28 and EXTRA – EU28 during January 2013 – December 2015

In the year 2015, important weights in the structure of exports and imports are represented by the following groups of goods: machinery and transport equipment (44.5% for export and 37.3% for import) and other manufactured goods^{*)} (32.8% for export and 31.0% for import, respectively).
