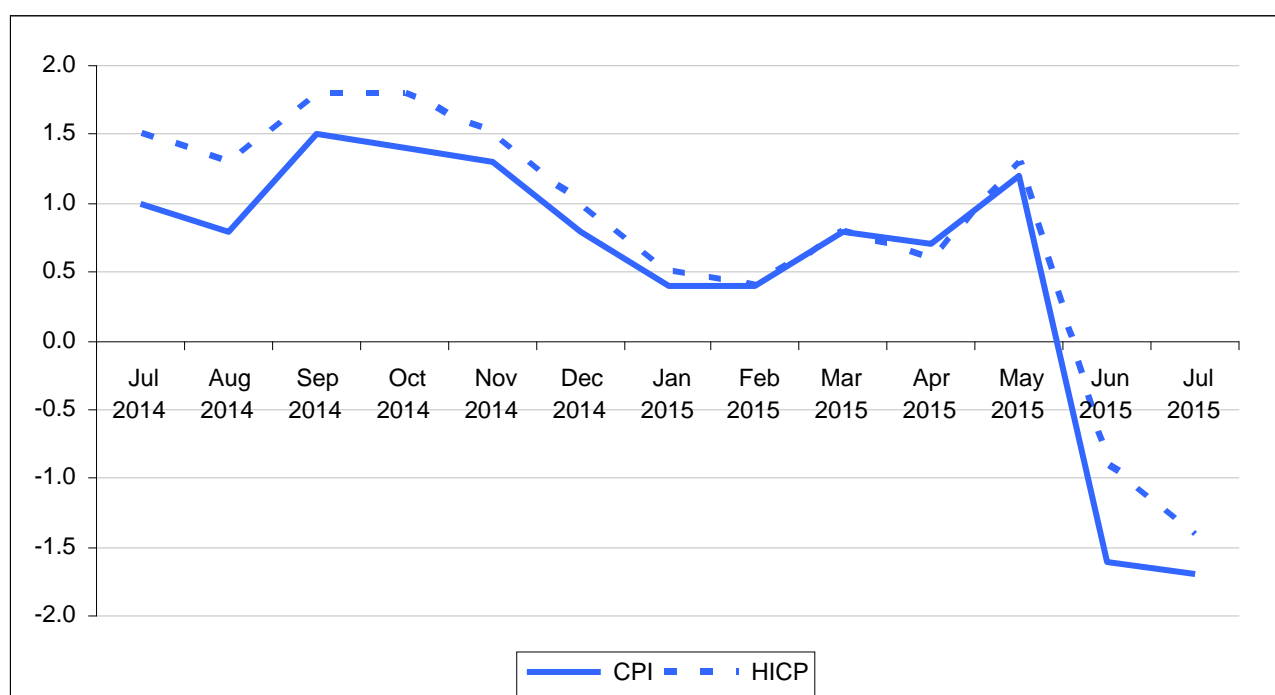


Domain: Consumer prices

## IN JULY 2015, THE ANNUAL RATE OF CONSUMER PRICES WAS -1.7%

- In July 2015 compared to July 2014, the consumer prices were 1.7% lower as measured by the CPI and 1.4% lower as measured by the HICP.
- In July 2015, the weight of the goods and services for which a price fall was observed compared to July 2014 was 40.0%; the goods and services whose prices increased within a range of 0-2.5% had a weight of 34.5%. The goods and services whose prices grew by more than 2.5% had a weight of 25.5%.
- The average price increase based on the CPI over the last 12 months (August 2014-July 2015) as compared to the previous 12 months (August 2013-July 2014) was 0.5%. The price increase based on the HICP was 0.7%.

\*\*) In order to more accurately meet the need to analyse inflation, as of September 2014 the fruit group includes, besides fresh fruit, citrus and other exotic fruit.

For the calculation of the CPI in 2015, the weighting coefficients are determined based on the data from the Family Budget Survey for 2013. In the case of the HICP, the weighting coefficients are determined on the basis of the national accounts data for the same year, 2013.
