




Area: Industrial production prices

INDUSTRIAL PRODUCTION PRICES UP 0.2%

- Industrial production prices for the total (domestic market and non-domestic market) increased by 0.2% in February 2015 compared to January 2015.
- Industrial production prices for the total (domestic market and non-domestic market) decreased by 1.7% in February 2015 compared to February 2014.
