




Domain: Annual Gross domestic product - semi-final version

THE GROSS DOMESTIC PRODUCTS IN 2014 WAS, IN REAL TERMS, BY 3.0% HIGHER, AS COMPARED TO 2013.

The Gross Domestic Product evolution during 2005-2014 is shown in the graph below.

The Gross Domestic Product estimated for 2014 – semi-final data amounted to 667577.4.0 million lei current prices, increasing – in real terms – by 3.0% as against 2013.

As compared to the provisional version, in the semi-final version, the Gross Domestic Product estimated for 2013 increased by 0.1%.

The contribution of resources and uses to the growth rate of GDP

Ressources

In 2014, most significant changes in the contribution to GDP growth, between the two estimates, were recorded for:

- Construction, from 0.0% to +0.2%, as consequence of changing the activity volume by +2.0 percentage points (from 100.3% to 102.3%);
- Financial intermediation and insurance, from -0.1% to -0.4%, as consequence of changing the activity volume by -8.5 percentage points (from 97.3% to 88.8%);
- Public administration and defence; social insurance of public sector; education; health and social assitance, from 0.0% to +0.2%, as consequence of changing the activity volume by 2.1 percentage points (from 99.9% to 102.0%).

Expenditure

In 2014, changes in the contribution to GDP growth between the two estimates were recorded for:

- Households final consumption expenditure, from +2.7% to +2.5%, as consequence of increasing its volume by 0.4 percentage points (from 104.5% to 104.1%);
- Final consumption expenditure of General government, from +0.8% to +0.1%, as consequence of decreasing its volume by 5.0 percentage points (from 105.3% to 100.3%);
- Gross Fixed Capital Formation, from -0.8% to +0.6%, as consequence of changing its volume by +6.0 percentage points (from 96.5% to 102.5%).
