


Domain: International trade with goods

In the period 1.I-28.II 2015, exports and imports increased by 3.6% and by 3.3%, respectively, compared to the period 1.I-28.II 2014

- In the period 1.I-28.II 2015 FOB exports amounted to 8574.8 million euro and CIF imports amounted to 9138.1 million euro.
- In the period 1.I-28.II 2015, the FOB-CIF commercial deficit was of 563.3 million euro, 4.7 million euro less than in the period 1.I-28.II 2014.
- In February 2015, FOB exports were of 4390.7 million euro and CIF imports were of 4774.9 million euro, a commercial deficit of 68.8 million euro greater than in February 2014 being registered.
- Compared to January 2015, exports and imports increased by 4.9% and by 9.4%, respectively, in February 2015.

Exports, imports and FOB/CIF balance during January 2010 – February 2015



In the period 1.I-28.II 2015, the Intra-community trade of goods (Intra-EU28) amounted to 6350.0 million euro for dispatches and to 7100.1 million euro for arrivals, representing 74.1% of the total exports and 77.7% of the total imports.


In the period 1.I-28.II 2015, the Extra-community trade of goods (Extra-EU28) amounted to 2224.8 million euro for exports and to 2038.0 million euro for imports, representing 25.9% of the total exports and 22.3% of the total imports.

INTRA – EU28 exports and EXTRA – EU28 exports during January 2013 – February 2015






FOB-CIF balance for INTRA – EU28 and EXTRA – EU28 during January 2013 – February 2015

In the period 1.I-28.II 2015, important weights in the structure of exports and imports are represented by the following groups of goods: transport equipment and vehicles (43.9% for export and 36.9% for import) and other manufactured goods^{*)} (33.7% for export and 31.3% for import, respectively).
