


Domain: International trade with goods

In the period 1.I-31.VII 2015, exports and imports increased by 5.9% and by 7.0%, respectively, compared to the period 1.I-31.VII 2014

- In the period 1.I-31.VII 2015 FOB exports amounted to 32072.4 million euro and CIF imports amounted to 36007.5 million euro.
- In the period 1.I-31.VII 2015, the FOB-CIF commercial deficit was of 3935.1 million euro, 561.0 million euro more than in the period 1.I-31.VII 2014.
- In July 2015, FOB exports were of 5043.3 million euro and CIF imports were of 5684.9 million euro, a commercial deficit of 641.6 million euro being registered.
- Compared to June 2015, exports increased by 5.8% and imports increased by 3.6% in July 2015.

Exports, imports and FOB/CIF balance during January 2010 – July 2015



In the period 1.I-31.VII 2015, the Intra-community trade of goods (Intra-EU28) amounted to 23516.8 million euro for dispatches and to 27667.2 million euro for arrivals, representing 73.3% of the total exports and 76.8% of the total imports.


In the period 1.I-31.VII 2015, the Extra-community trade of goods (Extra-EU28) amounted to 8555.6 million euro for exports and to 8340.3 million euro for imports, representing 26.7% of the total exports and 23.2% of the total imports.

INTRA – EU28 exports and EXTRA – EU28 exports during January 2013 – July 2015






FOB-CIF balance for INTRA – EU28 and EXTRA – EU28 during January 2013 – July 2015

In the period 1.I-31.VII 2015, important weights in the structure of exports and imports are represented by the following groups of goods: transport equipment and vehicles (44.3% for export and 36.6% for import) and other manufactured goods^{*)} (33.1% for export and 31.5% for import, respectively).
