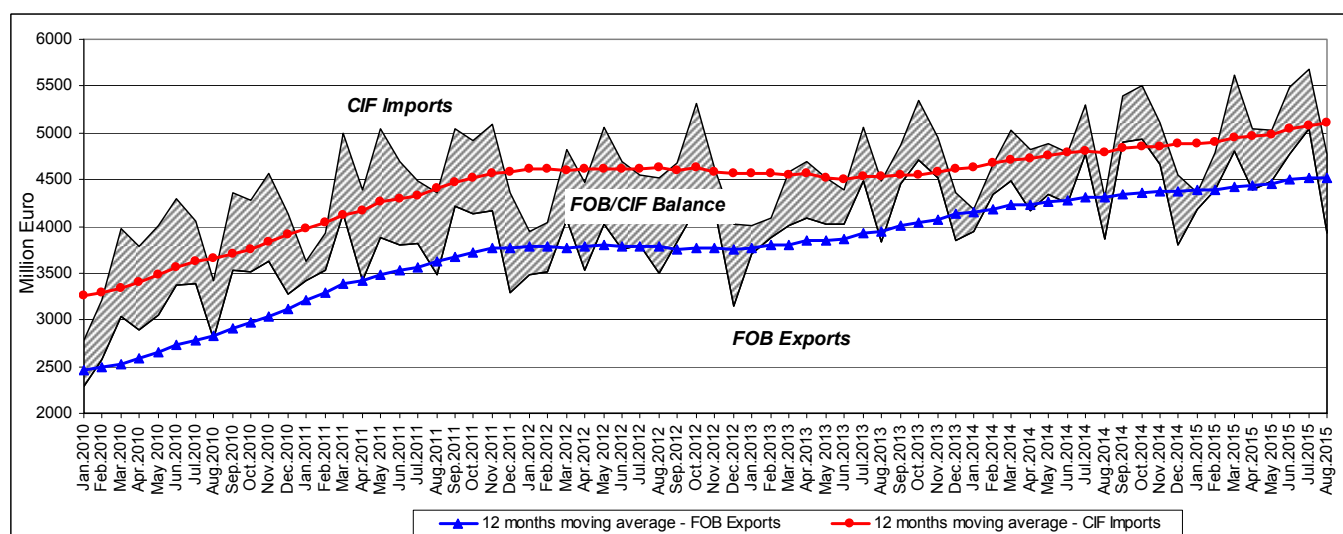


Domain: International trade with goods

In the period 1.I-31.VIII 2015, exports and imports increased by 5.4% and by 7.4%, respectively, compared to the period 1.I-31.VIII 2014

- In the period 1.I-31.VIII 2015 FOB exports amounted to 35993.3 million euro and CIF imports amounted to 40781.4 million euro.
- In the period 1.I-31.VIII 2015, the FOB-CIF commercial deficit was of 4788.1 million euro, 971.3 million euro more than in the period 1.I-31.VIII 2014.
- In August 2015, FOB exports were of 3920.7 million euro and CIF imports were of 4777.3 million euro, a commercial deficit of 856.6 million euro being registered.
- Compared to July 2015, exports decreased by 22.3% and imports decreased by 15.9% in August 2015.

Exports, imports and FOB/CIF balance during January 2010 – August 2015

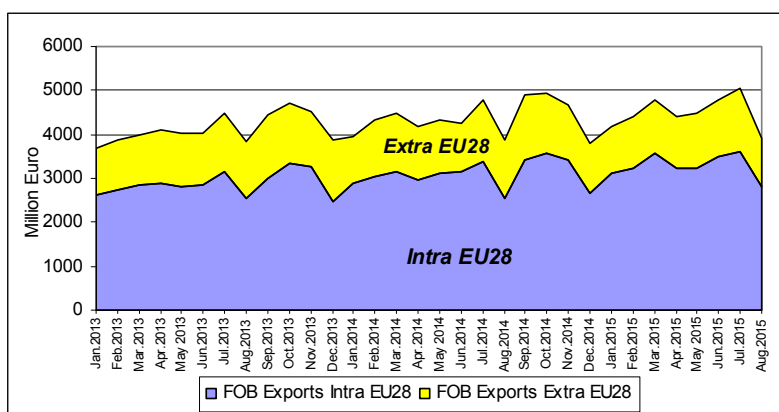

In the period 1.I-31.VIII 2015, the Intra-community trade of goods (Intra-EU28) amounted to 26327.5 million euro for dispatches and to 31251.1 million euro for arrivals, representing 73.1% of the total exports and 76.6% of the total imports.

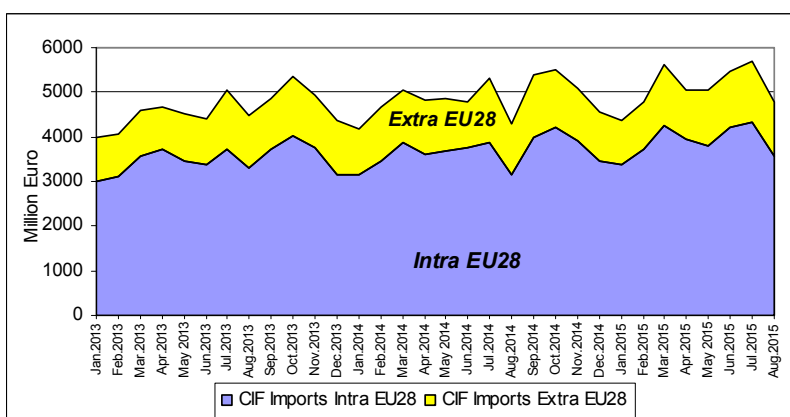
In the period 1.I-31.VIII 2015, the Extra-community trade of goods (Extra-EU28) amounted to 9665.8 million euro for exports and to 9530.3 million euro for imports, representing 26.9% of the total exports and 23.4% of the total imports.

INTRA – EU28 exports and EXTRA – EU28 exports during January 2013 – August 2015



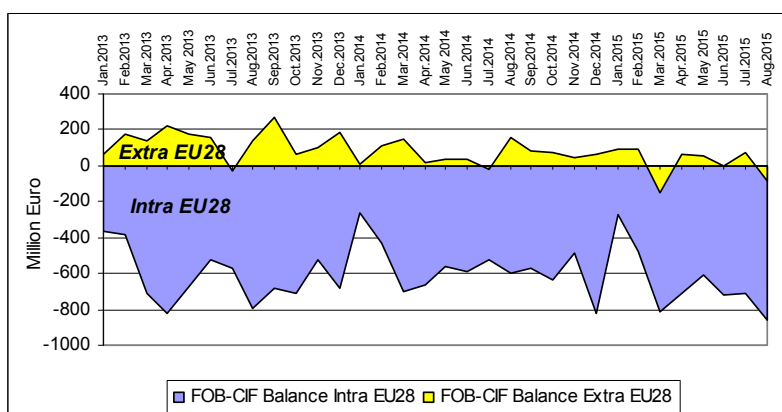

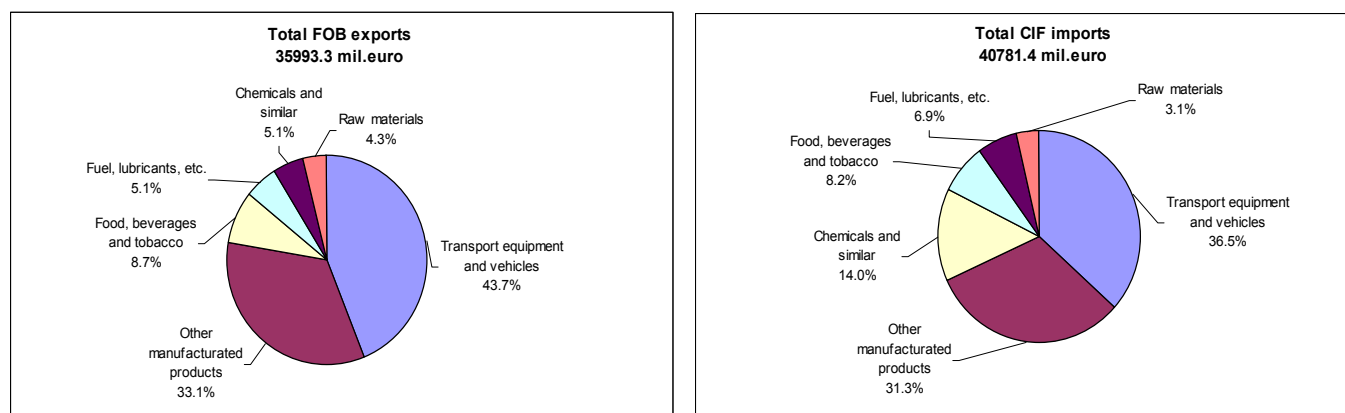
FOB-CIF balance for INTRA – EU28 and EXTRA – EU28 during January 2013 – August 2015

In the period 1.I-31.VIII 2015, important weights in the structure of exports and imports are represented by the following groups of goods: transport equipment and vehicles (43.7% for export and 36.5% for import) and other manufactured goods^{*)} (33.1% for export and 31.3% for import, respectively).
