

In the period 1.I-30.XI 2017, the exports and imports by 9.5% and by 12.3%, respectively, increased compared to the period 1.I-30.XI 2016

- In the period 1.I-30.XI 2017, the FOB exports amounted to 58146.8 million euro and the CIF imports amounted to 69491.2 million euro.
- In the period 1.I-30.XI 2017, the FOB-CIF commercial deficit was of 11344.4 million euro, 2569.9 million euro more than in the period 1.I-30.XI 2016.
- In November 2017, the FOB exports were of 5785.6 million euro and the CIF imports were of 6908.2 million euro, a commercial deficit of 1122.6 million euro being registered.
- Compared to November 2016, the exports increased by 8.9% and the imports increased by 11.8% in November 2017.

Exports, imports and FOB/CIF balance during January 2012 – November 2017



In the period 1.I-30.XI 2017, the Intra-EU28 trade of goods amounted to 44168.0 million euro for dispatches and to 52721.3 million euro for arrivals, representing 76.0% of total exports and 75.9% of total imports.


In the period 1.I-30.XI 2017, the Extra-EU28 trade of goods amounted to 13978.8 million euro for exports and to 16769.9 million euro for imports, representing 24.0% of total exports and 24.1% of total imports.

INTRA - EU28 and EXTRA - EU28 exports during January 2015 - November 2017






FOB-CIF balance for INTRA – EU28 and EXTRA – EU28 during January 2015 – November 2017



In the period 1.I-30.XI 2017, important weights in the structure of exports and imports are represented by the following groups of goods: machinery and transport equipment (46.4% for export and 37.3% for import) and other manufactured goods*) (33.4% for export and 30.9% for import, respectively).

Additional information:

FOB/CIF trade balance is calculated on the basis of the FOB export value and CIF import value as difference between them. The negative balance of the trade balance is called deficit and the positive one is called excedent.

FOB price (Free on Board) represents **the price at the border of the exporting country**, which includes the value of the commodity, all transport expenditures to the shipping point as well as all the fees for the commodity to be loaded on board.

CIF price (Cost, Insurance, Freight) represents **the price at the border of the importing country**, including both components of FOB price and the cost of insurance as well as the cost of the international transport.

For a correct interpretation of the indicators, kindly see the Methodological Notes.
