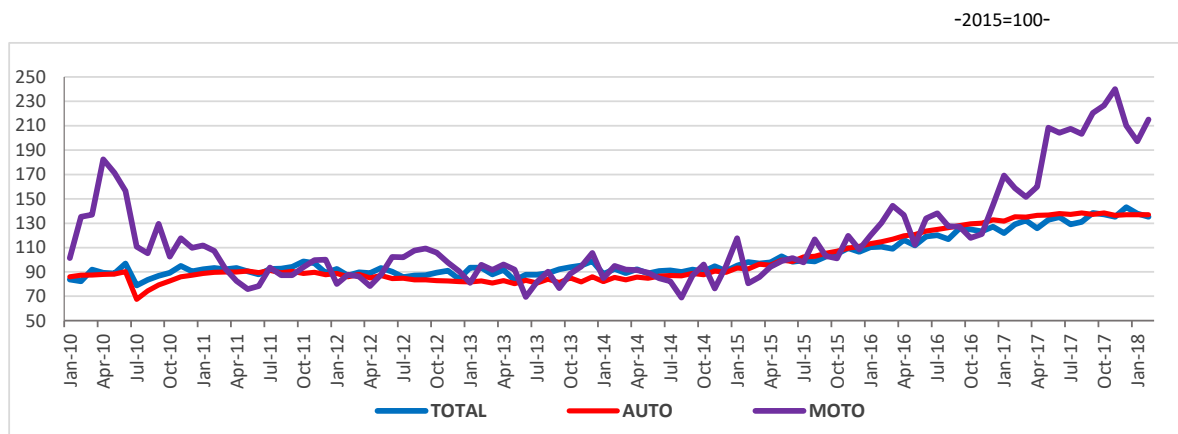


Domain: Trade – services

In February 2018¹, compared to January 2018, the turnover of the trade with motor vehicles and the turnover of the market services provided to the population decreased by 1.9% and by 1.1%, respectively

- Compared to the previous month, in February 2018 **the turnover volume of the trade with motor vehicles and motorcycles** increased as gross series by **5.7%** and decreased as adjusted series according to the number of working days and to seasonality by **1.9%**. **The turnover volume of the market services provided to the population** decreased compared to the previous month both as gross series by **3.1%** and as adjusted series according to the number of working days and to seasonality by **1.1%**.
- Compared to the corresponding month of the previous year, **the turnover volume of the trade with motor vehicles and motorcycles** increased both as gross series and as adjusted series according to the number of working days and to seasonality by **4.7%** and by **4.9%**, respectively. Compared to the corresponding month of the previous year, **the turnover volume of the market services provided to the population** increased both as gross series by **6.4%** and as adjusted series according to the number of working days and to seasonality by **6.1%**.
- In the period 1.I-28.II.2018, compared to the period 1.I-28.II.2017, **the turnover volume of the trade with motor vehicles and motorcycles** increased both as gross series by **8.7%** and as adjusted series according to the number of working days and to seasonality by **8.9%**. **The turnover volume of the market services provided to the population** increased both as gross series by **7.9%** and as adjusted series according to the number of working days and to seasonality by **7.1%**.

- January 2010 – February 2018 -**

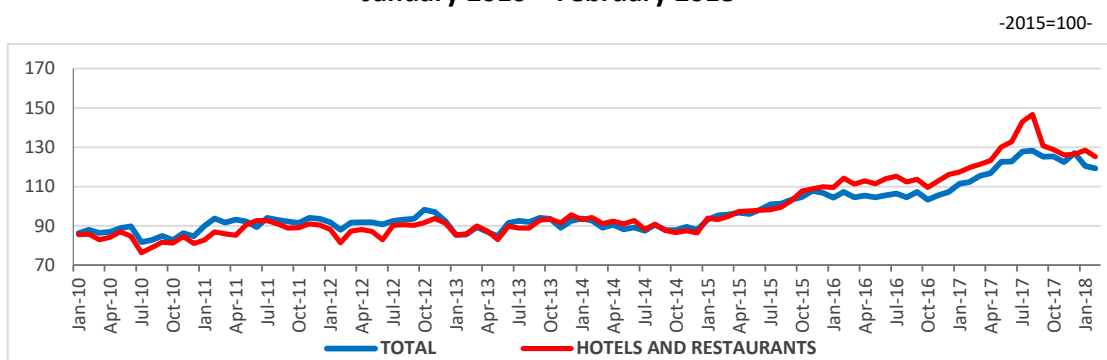

February 2018 compared to January 2018

Compared to the previous month, in February 2018 **the turnover volume of wholesale and retail, the maintenance and repair of motor vehicles and motorcycles, gross series**, increased by 5.7% due to increases registered in the trade with motor vehicles (+11.3%), in the trade with motorcycles, spare parts and related accessories; maintenance and repair of motorcycles (+6.8%) and in the maintenance and repair activities of motor vehicles (+3.0%). The trade with spare parts and accessories for motor vehicles decreased by 3.1%.

Compared to the previous month, **the turnover volume of wholesale and retail, the maintenance and repair of motor vehicles and motorcycles, adjusted series according to the number of working days and to the seasonality**, decreased by 1.9% in February 2018.

As to the **market services provided to the population, gross series**, in February 2018, compared to the previous month, the turnover volume decreased by 3.1% due to drops registered in the services of hairdressing and other embellishment activities (-9.0%), in the activities of gambling and other recreational activities (-8.1%), in the activities of hotels and restaurants (-4.4%) and in the activities of washing, cleaning (dry) of textile articles and fur products (-4.1%). The activities of travel agencies and tour operators increased by 16.5%.

Compared to the previous month, in February 2018, **the turnover volume for the market services provided to the population, adjusted series according to the number of working days and to the seasonality**, decreased by 1.1%.

February 2018 compared to February 2017

Compared to February 2017, in February 2018 **the turnover volume of wholesale and retail, the maintenance and repair of motor vehicles and motorcycles, gross series**, increased by 4.7% due to rises in the trade with motorcycles, spare parts and related accessories; the maintenance and repair of motorcycles (+34.7%) and in the trade with motor vehicles (+11.2%). Drops were registered by the maintenance and repair activities of motor vehicles (-7.1%) and in the trade with spare parts and accessories for motor vehicles (-1.8%).

In February 2018, **the turnover volume of wholesale and retail, the maintenance and repair of motor vehicles and motorcycles, adjusted series according to the number of working days and to the seasonality**, increased by 4.9% compared to February 2017.

In February 2018, **the market services provided to the population, gross series**, registered a turnover of 6.4% more compared to February 2017 due to rises in the activities of travel agencies and tour operators (+29.4%), in the activities of washing, cleaning (dry) of textile articles and fur products (+7.1%), in the activities of hotels and restaurants (+4.5%) and in the activities of gambling and other recreational activities (+1.1%). The hairdressing and other embellishment activities decreased by 3.6%.

In February 2018, **the market services provided to the population, adjusted series according to the number of working days and to the seasonality**, increased by 6.1% compared to February 2017.

Period 1.I-28.II.2018 compared to period 1.I-28.II.2017

Compared to the period 1.I-28.II.2017, in the period 1.I-28.II.2018 **the turnover volume of wholesale and retail, the maintenance and repair of motor vehicles and motorcycles, gross series**, increased by 8.7% due to rises in the trade with motorcycles, spare parts and related accessories; the maintenance and repair of motorcycles (+24.3%), in the trade with motor vehicles (+15.2%) and in the trade with spare parts and accessories for motor vehicles (+3.5%). The maintenance and repair activities of motor vehicles decreased by 4.1%.

In the period 1.I-28.II.2018, **the turnover volume of wholesale and retail, the maintenance and repair of motor vehicles and motorcycles, adjusted series according to the number of working days and to the seasonality**, increased by 8.9% compared to the period 1.I-28.II.2017.

In the period 1.I-28.II.2018, **the market services provided to the population, gross series**, registered a turnover of 7.9% more compared to the period 1.I-28.II.2017 due to rises in the activities of travel agencies and tour operators (+21.1%), in the activities of washing, cleaning (dry) of textile articles and fur products (+13.0%), in the activities of hotels and restaurants (+8.1%), in the activities of gambling and other recreational activities (+1.2%) and in the hairdressing and other embellishment activities (+1.1%).

In the period 1.I-28.II.2018, **the market services provided to the population, adjusted series according to the number of working days and to the seasonality**, registered a turnover of 7.1% more compared to the period 1.I-28.II.2017.

Additional information:

- ✓ **IMPORTANT!** In order to highlight the changes in the economy structure, starting with the data release for **January 2018** reference month, the base year used for the calculation of the indices, for all short-term indicators, was changed from 2010 to 2015.
- ✓ The changing of the base year involves the updating of the weighting system, to reflect the structural modifications occurred in the national economy activities. These modifications determined the proper recalculation and revision of the data series previously published.
- ✓ These changes will appear in press releases, statistical publications published by the INS and in the TEMPO online database.
- ✓ The turnover represents the total revenue recorded by the company during the reporting period, obtained both from the main activity and the secondary activities performed by it. The turnover does not include the revenue from the sale or transfer of assets.
- ✓ The volume indices of the turnover in trade with motor vehicles and motorcycles and in the market services rendered to the population are Laspeyres type indices and are calculated under comparable prices and methodological conditions. For expressing the values of the current period in prices of the reference period the deflating price indices are used (consumer price index). The first indices obtained are at the level of class/group CANE Rev. 2, then, by successive aggregations indices at aggregate levels are obtained. The weights used for aggregation are calculated based on the turnover according to the results of the Business Structural Survey from the reference year (2015).
