

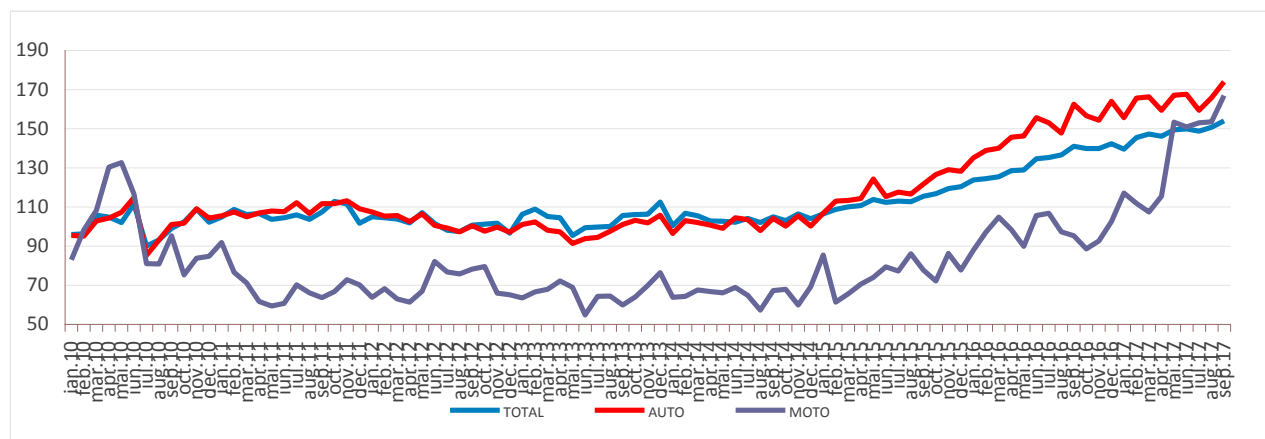
Domain: Trade - services

Compared to the previous month, in September 2017¹, the turnover of the trade with motor vehicles increased by 2.1% and the turnover of the market services provided to the population decreased by 1.0%

- Compared to the previous month, in September 2017, **the turnover volume of the trade with motor vehicles and motorcycles** increased both as gross series by **5.8%** and as adjusted series according to the number of working days and to seasonality by **2.1%**. **The turnover volume of the market services provided to the population** decreased compared to the previous month both as gross series by **10.8%** and as adjusted series according to the number of working days and to seasonality by **1.0%**.
- Compared to the corresponding month of the previous year, **the turnover volume of the trade with motor vehicles and motorcycles** increased both as gross series by **6.9%** and as adjusted series according to the number of working days and to seasonality by **9.1%**. Compared to the corresponding month of the previous year, **the turnover volume of the market services provided to the population** increased both as gross series by **15.2%** and as adjusted series according to the number of working days and to seasonality by **17.2%**.
- Compared to the period 1.I-30.IX.2016, in the period 1.I-30.IX.2017 **the turnover volume of the trade with motor vehicles and motorcycles** increased both as gross series by **11.7%** and as adjusted series according to the number of working days and to seasonality by **12.9%**. **The turnover volume of the market services provided to the population** increased both as gross series by **14.1%** and as adjusted series according to the number of working days and to seasonality by **12.6%**.

- January 2010 – September 2017 -**

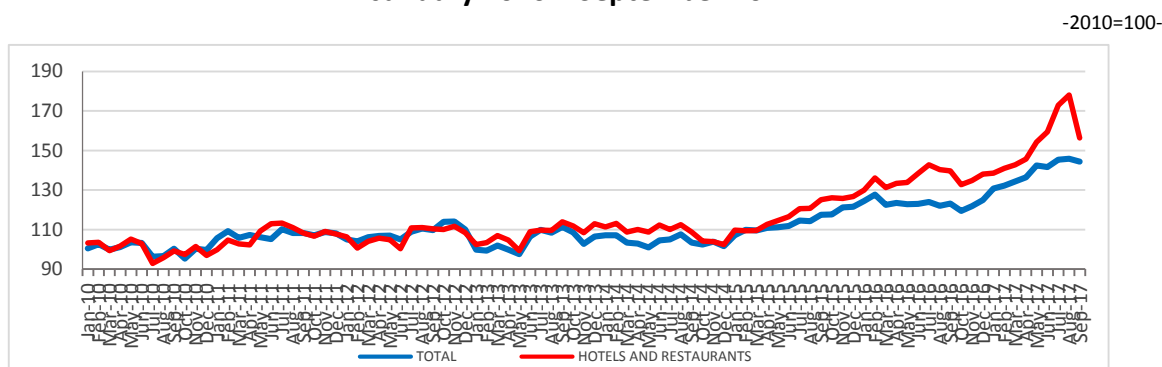

September 2017 compared to August 2017

Compared to the previous month, in September 2017 **the turnover volume of wholesale and retail, the maintenance and repair of motor vehicles and motorcycles, gross series**, increased by 5.8% due to rises in the trade with motor vehicles (+10.9%) and in the maintenance and repair activities of motor vehicles (+3.9%). Drops were registered in: the trade with motorcycles, spare parts and related accessories; maintenance and repair of motorcycles (-12.0%) and in the trade with spare parts and accessories for motor vehicles (-1.3%).

Compared to the previous month, **the turnover volume of wholesale and retail, the maintenance and repair of motor vehicles and motorcycles, adjusted series according to the number of working days and to the seasonality**, increased by 2.1% in September 2017.

As to the **market services provided to the population, gross series**, in September 2017, compared to the previous month, the turnover volume decreased by 10.8% due to drops in the activities of hotels and restaurants (-17.0%) and in the activities of travel agencies and tour operators (-1.9%). Increases were registered in: the services of hairdressing and other embellishment activities (+2.6%), the activities of washing, cleaning and dyeing of textiles and furs (+2.3%) and in the activities of gambling and other recreational activities (+0.4%).

Compared to the previous month, in September 2017, **the turnover volume for the services provided to the population, adjusted series according to the number of working days and to the seasonality**, decreased by 1.0%.

September 2017 compared to September 2016

Compared to September 2016, in September 2017, **the turnover volume of wholesale and retail, the maintenance and repair of motor vehicles and motorcycles, gross series**, increased by 6.9% due to rises in the trade with motorcycles, spare parts and related accessories; the maintenance and repair of motorcycles (+76.0%), in the maintenance and repair activities of motor vehicles (+18.3%), in the trade with spare parts and accessories for motor vehicles (+6.2%) and in the trade with motor vehicles (+4.6%).

In September 2017, **the turnover volume of wholesale and retail, the maintenance and repair of motor vehicles and motorcycles, adjusted series according to the number of working days and to the seasonality**, increased by 9.1% compared to September 2016.

In September 2017, **the market services provided to the population, gross series**, registered a turnover of 15.2% more compared to September 2016 due to rises in the activities of gambling and other recreational activities (+34.9%), in the activities of washing, cleaning and dyeing of textiles and furs (+14.6%) and in the activities of hotels and restaurants (+12.7%). Drops were registered in the hairdressing and other embellishment activities (-25.3%) and in the activities of travel agencies and tour operators (-0.1%).

In September 2017, **the market services provided to the population, adjusted series according to the number of working days and to the seasonality**, increased by 17.2% compared to September 2016.

Period 1.I-30.IX.2017 compared to period 1.I-30.IX.2016

Compared to the period 1.I-30.IX.2016, in the period 1.I-30.IX.2017, **the turnover volume of wholesale and retail, the maintenance and repair of motor vehicles and motorcycles, gross series**, increased by 11.7% due to rises in the trade with motorcycles, spare parts and related accessories; the maintenance and repair of motorcycles (+44.0%), in the maintenance and repair activities of motor vehicles (+25.7%), in the trade with motor vehicles (+9.8%) and in the trade with spare parts and accessories for motor vehicles (+9.0%).

Compared to the period 1.I-30.IX.2016, in the period 1.I-30.IX.2017, **the turnover volume of wholesale and retail, the maintenance and repair of motor vehicles and motorcycles, adjusted series according to the number of working days and to the seasonality**, increased by 12.9%.

In the period 1.I-30.IX.2017, **the market services provided to the population, gross series** registered a turnover of 14.1% more compared to the period 1.I-30.IX.2016 due to rises in the activities of gambling and other recreational activities (+18.9%), in the activities of hotels and restaurants (+14.3%), in the activities of washing, cleaning and dyeing of textiles and furs (+10.6%) and in the activities of travel agencies and tour operators (+9.1%). The hairdressing and other embellishment activities decreased by 16.4%.

In the period 1.I-30.IX.2017, the **market services provided to the population, adjusted series according to the number of working days and to the seasonality** registered a turnover of 12.6% more compared to the period 1.I-30.IX.2016.

Additional information:

- ✓ The turnover represents the total revenue recorded by the company during the reporting period, obtained both from the main activity and the secondary activities performed by it. The turnover does not include the revenue from the sale or transfer of assets.
- ✓ The volume indices of the turnover in trade with motor vehicles and motorcycles and in the market services rendered to the population are Laspeyres type indices and are calculated under comparable prices and methodological conditions. For expressing the values of the current period in prices of the reference period the deflating price indices are used (consumer price index). The first indices obtained are at the level of class/group CANE Rev. 2, then, by successive aggregations indices at aggregate levels are obtained. The weights used for aggregation are calculated based on the turnover according to the results of the Business Structural Survey from the reference year (2010).
