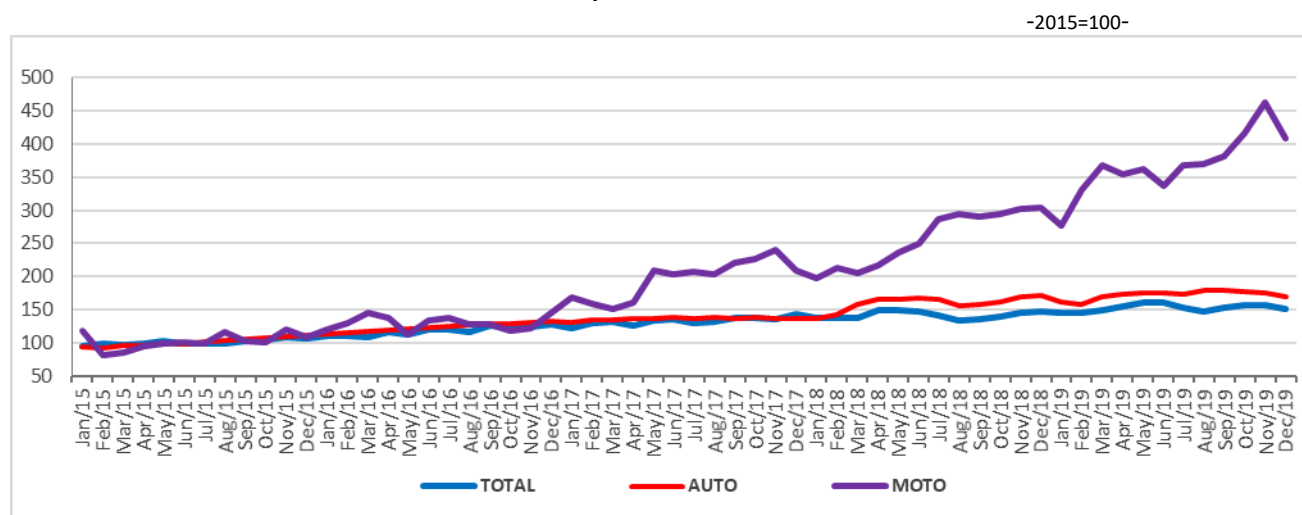


Domain: Trade – services

The turnover of the trade with motor vehicles and of the market services provided to the population in December 2019

- Compared to the previous month, in December 2019 **the turnover volume of the trade with motor vehicles and motorcycles** decreased both as gross series by **10.8%** and as adjusted series according to the number of working days and to seasonality by **4.1%**.
- The turnover volume of the market services provided to the population**, compared to the previous month, increased both as gross series by **5.2%** and as adjusted series according to the number of working days and to seasonality by **3.4%**.
- Compared to the corresponding month of the previous year, **the turnover volume of the trade with motor vehicles and motorcycles** increased both as gross series by **4.5%** and as adjusted series according to the number of working days and to seasonality by **2.3%**.
- Compared to the corresponding month of the previous year, **the turnover volume of the market services provided to the population** increased both as gross series by **17.6%** and as adjusted series according to the number of working days and to seasonality by **19.8%**.
- Compared to the period 1.I-31.XII.2018, in the period 1.I-31.XII.2019 **the turnover volume of the trade with motor vehicles and motorcycles** increased as gross series by **8.2%**.
- Compared to the corresponding period of the previous year, in the period 1.I-31.XII.2019 **the turnover volume of the market services provided to the population** increased as gross series by **13.9%**.

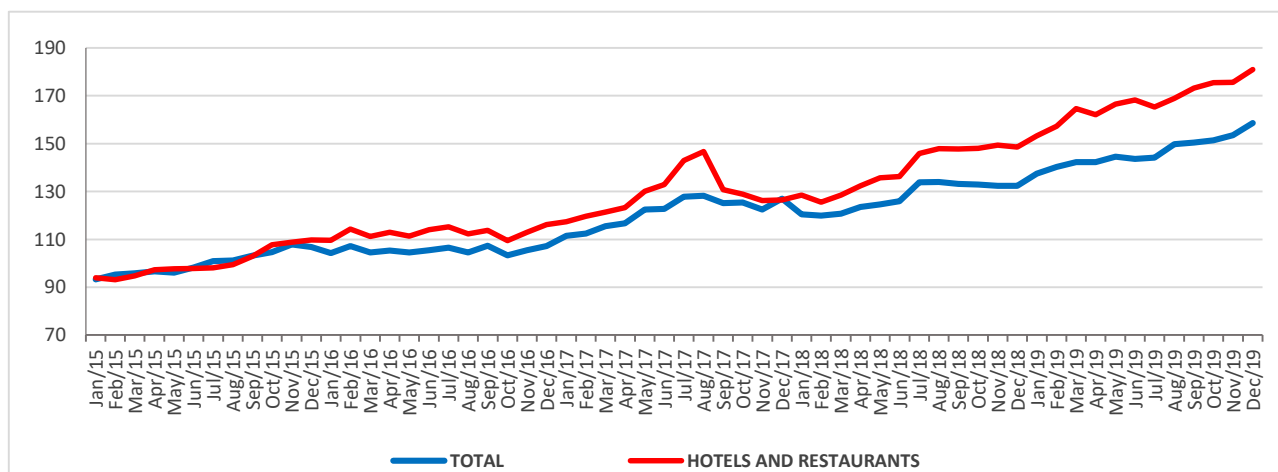

December 2019 compared to November 2019

Compared to the previous month, in December 2019 **the total turnover volume of wholesale and retail, the maintenance and repair of motor vehicles and motorcycles, gross series**, decreased by 10.8% due to drops registered in the trade with motorcycles, spare parts and related accessories; maintenance and repair of motorcycles (-22.1%), in the trade with spare parts and accessories for motor vehicles (-21.6%), in the maintenance and repair activities of motor vehicles (-14.4%) and in the trade with motor vehicles (-4.5%).

Compared to the previous month, **the total turnover volume of wholesale and retail, the maintenance and repair of motor vehicles and motorcycles, adjusted series according to the number of working days and to the seasonality**, decreased by 4.1% in December 2019.

As to the **market services provided to the population, gross series**, in December 2019, compared to the previous month, the turnover volume increased by 5.2% due to rises registered in the services of hairdressing and other embellishment activities (+18.7%), in the activities of gambling and other recreational activities (+12.3%), in the activities of washing, cleaning (dry) of textile articles and fur products (+5.4%) and in the activities of hotels and restaurants (+3.2%). Decreases were registered in the activities of travel agencies and tour operators (-1.2%).

Compared to the previous month, in December 2019 **the turnover volume for the market services provided to the population, adjusted series according to the number of working days and to the seasonality**, increased by 3.4%.

December 2019 compared to December 2018

Compared to December 2018, in December 2019 **the total turnover volume of wholesale and retail, the maintenance and repair of motor vehicles and motorcycles, gross series**, increased by 4.5% due to increases registered in the trade with motorcycles, spare parts and related accessories; the maintenance and repair of motorcycles (+32.4%), in the trade with spare parts and accessories for motor vehicles (+15.9%), in the maintenance and repair activities of motor vehicles (+3.5%) and in the trade with motor vehicles (+0.3%).

In December 2019, **the total turnover volume of wholesale and retail, the maintenance and repair of motor vehicles and motorcycles, adjusted series according to the number of working days and to the seasonality**, increased by 2.3% compared to December 2018.

In December 2019, **the market services provided to the population, gross series**, registered a turnover of 17.6% more compared to December 2018 due to rises in the activities of hotels and restaurants (+23.3%), in the activities of gambling and other recreational activities (+18.1%), in the activities of washing, cleaning (dry) of textile articles and fur products (+14.6%) and in the hairdressing and other embellishment activities (+12.1%). The activities of travel agencies and tour operators decreased by 8.5%.

In December 2019, **the market services provided to the population, adjusted series according to the number of working days and to the seasonality**, increased by 19.8% compared to December 2018.

Period 1.I-31.XII.2019 compared to period 1.I-31.XII.2018

Compared to period 1.I-31.XII.2018, in the period 1.I-31.XII.2019 **the total turnover volume of wholesale and retail, the maintenance and repair of motor vehicles and motorcycles, gross series**, increased by 8.2%, increase sustained by: the trade with motorcycles, spare parts and related accessories; the maintenance and repair of motorcycles (+36.7%), the trade with spare parts and accessories for motor vehicles (+9.6%), the trade with motor vehicles (+7.2%) and the maintenance and repair activities of motor vehicles (+7.2%).

In the period 1.I-31.XII.2019 **the market services provided to the population, gross series**, registered a turnover of 13.9% more compared to the period 1.I-31.XII.2018 due to rises in the activities of hotels and restaurants (+20.1%), in the activities of washing, cleaning (dry) of textile articles and fur products (+16.1%), in the hairdressing and other embellishment activities (+13.3%) and in the activities of gambling and other recreational activities (+8.3%). The activities of travel agencies and tour operators decreased by 6.4%.

Additional information:

- ✓ The turnover represents the total revenue recorded by the company during the reporting period, obtained both from the main activity and the secondary activities performed by it. The turnover does not include the revenue from the sale or transfer of assets.
- ✓ The volume indices of the turnover in trade with motor vehicles and motorcycles and in the market services rendered to the population are Laspeyres type indices and are calculated under comparable prices and methodological conditions. For expressing the values of the current period in prices of the reference period the deflating price indices are used (consumer price index). The first indices obtained are at the level of class/group CANE Rev. 2, then, by successive aggregations indices at aggregate levels are obtained. The weights used for aggregation are calculated based on the turnover according to the results of the Business Structural Survey from the reference year (2015).
