Domain: Trade - services

The turnover of market services rendered mainly to enterprises in May 2018

- Compared to the previous month, in May 2018 the turnover of market services rendered mainly to enterprises, in nominal terms, increased as gross series by 5.2% and decreased as adjusted series according to the number of working days and to seasonality by 0.4%.
- Compared to the corresponding month of the previous year, the turnover of market services rendered mainly to enterprises, in nominal terms, increased both as gross series by 5.1% and as adjusted series according to the number of working days and to seasonality by 6.0%.
- Compared to the period 1.I-31.V-2017, in the period 1.I-31.V.2018 the turnover of market services rendered mainly to enterprises, in nominal terms, increased both as gross series by 7.5% and as adjusted series according to the number of working days and to seasonality by 8.7%.

- 2015=100 -



May 2018 compared to April 2018

Compared to the previous month, in May 2018 the turnover of market services rendered mainly to enterprises, gross series, in nominal terms, increased by 5.2% due to rises registered in motion picture, video and television programme production; programming and broadcasting activities (+15.5%), in information service activities and information technology activities (+11.4%), in communication activities (+5.8%), in transport activities (+5.5%) and in other services rendered mainly to enterprises (+2.9%).

Compared to the previous month, in May 2018 the turnover of market services rendered mainly to enterprises, adjusted series according to the number of working days and to seasonality, in nominal terms, decreased by 0.4% due to drops registered in information service activities and information technology activities (-3.8%). Increases were registered in motion picture, video and television programme production; programming and broadcasting activities (+16.3%), in communication (+1.4%), in transports (+0.9%) and in other services rendered mainly to enterprises (+0.1%).

May 2018 compared to May 2017

Compared to May 2017, in May 2018 the turnover of market services rendered mainly to enterprises, gross series, in nominal terms, globally increased by 5.1% due to rises registered in motion picture, video and television programme production; programming and broadcasting activities (+10.8%), in other services rendered mainly to enterprises (+7.0%), in communication (+6.5%) and in transports (+4.3%). The information service activities and information technology activities decreased by 1.8%.

Compared to May 2017, in May 2018 the turnover of market services rendered mainly to enterprises, adjusted series according to the number of working days and seasonality, in nominal terms, globally increased by 6.0% due to rises registered in motion picture, video and television programme production; programming and broadcasting activities (+9.1%), in other services rendered mainly to enterprises (+8.0%), in communication (+6.1%), in transports (+5.6%) and in information service and information technology activities (+2.3%).

Period 1.I-31.V.2018 compared to period 1.I-31.V.2017

Compared to period 1.I-31.V.2017, in the period 1.I-31.V.2018 the turnover of market services rendered mainly to enterprises, gross series, in nominal terms, globally increased by 7.5% due to rises registered in other services rendered mainly to enterprises (+9.0%), in information service activities and information technology activities (+7.2%), in communication (+6.5%), in transports (+6.3%) and in motion picture, video and television programme production; programming and broadcasting activities (+5.5%).

Compared to period 1.I-31.V.2017, in the period 1.I-31.V.2018 the turnover of market services rendered mainly to enterprises, adjusted series according to the number of working days and seasonality, in nominal terms, globally increased by 8.7% due to rises registered in other services rendered mainly to enterprises (+10.2%), in transports (+7.6%), in communication (+6.7%), in information service and information technology activities (+5.8%) and in motion picture, video and television programme production; programming and broadcasting activities (+5.2%).

Additional information:

- ✓ IMPORTANT! In order to highlight the changes in the economy structure, starting with the data release for January 2018 reference month, the base year used for the calculation of the indices, for all short-term indicators, was changed from 2010 to 2015.
- ✓ The changing of the base year involves the updating of the weighting system, to reflect the structural modifications occurred in the national economy activities. These modifications determined the proper recalculation and revision of the data series previously published.
- ✓ These changes will appear in press releases, statistical publications published by the INS and in the TEMPO online database.
- ✓ The turnover represents the total revenue recorded by the company during the reporting period, obtained from both the main activity and the secondary activities performed. The turnover does not include VAT and the revenue from the sale or transfer of assets.
- ✓ The value indices of the turnover of market services rendered mainly to enterprises are Laspeyres-type indices. The first indices obtained are at CANE Rev.2 level and then, by successive aggregations, indices at total level are obtained. The weights used for aggregation are calculated based on the turnover according to the results of the Structural Business Survey of the reference year (2015).
