# The turnover of market services rendered mainly to enterprises in September 2018

- Compared to the previous month, in September 2018 the turnover of market services rendered mainly to enterprises, in nominal terms, increased as gross series by 1.8% and decreased as adjusted series according to the number of working days and to seasonality by 0.3%.
- Compared to the corresponding month of the previous year, the turnover of market services rendered mainly to enterprises, in nominal terms, increased both as gross series by 9.0% and as adjusted series according to the number of working days and to seasonality by 10.6%.
- Compared to the period 1.I-30.IX-2017, in the period 1.I-30.IX.2018 the turnover of market services rendered mainly to enterprises, in nominal terms, increased both as gross series by 8.7% and as adjusted series according to the number of working days and to seasonality by 9.6%.

- 2015=100 -



#### **September 2018 compared to August 2018**

Compared to the previous month, in September 2018 the turnover of market services rendered mainly to enterprises, gross series, in nominal terms, increased by 1.8% due to rises registered in motion picture, video and television programme production; programming and broadcasting activities (+15.8%), in information service activities and information technology activities (+8.8%), in other services rendered mainly to enterprises (+3.1%) and in transport activities (+0.2%). The communication activities decreased by 5.4%.

Compared to the previous month, in September 2018 the turnover of market services rendered mainly to enterprises, adjusted series according to the number of working days and to seasonality, in nominal terms, decreased by 0.3% due to drops registered in motion picture, video and television programme production; programming and broadcasting activities (-6.3%), in other services rendered mainly to enterprises (-1.4%), in communication (-1.4%) and in transports (-0.2%). Increases were registered in information service activities and information technology activities (+4.5%).

#### September 2018 compared to September 2017

Compared to September 2017, in September 2018 the turnover of market services rendered mainly to enterprises, gross series, in nominal terms, globally increased by 9.0% due to rises registered in information service and information technology activities (+15.1%), in other services rendered mainly to enterprises (+14.4%), in transports (+4.8%), in motion picture, video and television programme production; programming and broadcasting activities (+4.3%) and in communication (+0.9%).

Compared to September 2017, in September 2018 the turnover of market services rendered mainly to enterprises, adjusted series according to the number of working days and seasonality, in nominal terms, globally increased by 10.6% due to rises registered in other services rendered mainly to enterprises (+15.5%), in information service and information technology activities (+12.8%), in motion picture, video and television programme production; programming and broadcasting activities (+5.7%), in transports (+5.6%) and in communication (+3.5%).

#### Period 1.I-30.IX.2018 compared to period 1.I-30.IX.2017

Compared to period 1.I-30.IX.2017, in the period 1.I-30.IX.2018 **the turnover of market services rendered mainly to enterprises**, gross series, in nominal terms, globally increased by 8.7% due to rises registered in other services rendered mainly to enterprises (+11.7%), in information service activities and information technology activities (+10.3%), in motion picture, video and television programme production; programming and broadcasting activities (+7.2%), in communication (+6.5%) and in transports (+6.1%).

Compared to period 1.I-30.IX.2017, in the period 1.I-30.IX.2018 **the turnover of market services rendered mainly to enterprises**, adjusted series according to the number of working days and seasonality, in nominal terms, globally increased by 9.6% due to rises registered in other services rendered mainly to enterprises (+12.1%), in information service and information technology activities (+8.4%), in motion picture, video and television programme production; programming and broadcasting activities (+7.5%), in transports (+6.9%) and in communication (+6.5%).

#### Additional information:

- ✓ IMPORTANT! In order to highlight the changes in the economy structure, starting with the data release for January 2018 reference month, the base year used for the calculation of the indices, for all short-term indicators, was changed from 2010 to 2015.
- ✓ The changing of the base year involves the updating of the weighting system, to reflect the structural modifications occurred in the national economy activities. These modifications determined the proper recalculation and revision of the data series previously published.
- ✓ These changes will appear in press releases, statistical publications published by the INS and in the TEMPO online database.
- ✓ The turnover represents the total revenue recorded by the company during the reporting period, obtained from both the main activity and the secondary activities performed. The turnover does not include VAT and the revenue from the sale or transfer of assets.
- ✓ The value indices of the turnover of market services rendered mainly to enterprises are Laspeyres-type indices. The first indices obtained are at CANE Rev.2 level and then, by successive aggregations, indices at total level are obtained. The weights used for aggregation are calculated based on the turnover according to the results of the Structural Business Survey of the reference year (2015).
