

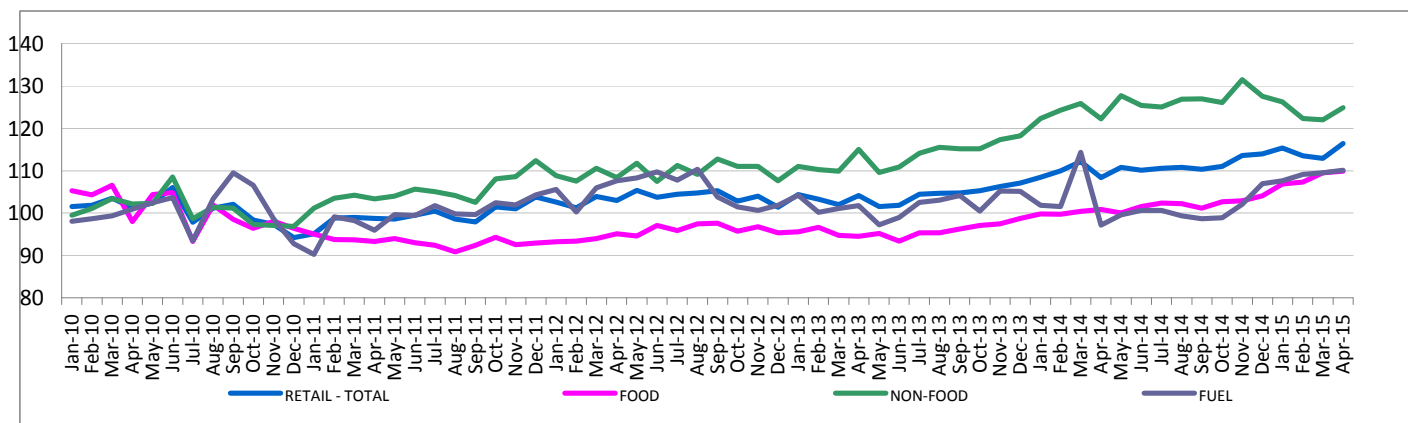

THE RETAIL TURNOVER INCREASED BY 7.1%

- As against the previous month, in April 2015 **the retail turnover volume (excluding the trade with motor vehicles and motorcycles)**, increased both as gross series by **7.1%** and as adjusted series according to the number of working days and to seasonality by **3.1%**.
- As against the corresponding month of the previous year, **the retail turnover volume (excluding the trade with motor vehicles and motorcycles)**, increased both as gross series and as adjusted series according to the number of working days and to seasonality by **7.1%** and by **7.5%**, respectively.
- As against the period 1.I – 30.IV.2014, in the period 1.I – 30.IV.2015 **the retail turnover volume (excluding the trade with motor vehicles and motorcycles)**, increased both as gross series and as adjusted series according to the number of working days and to seasonality by **4.3%** and by **4.4%**, respectively.

April 2015 as against March 2015

As against the previous month, in April 2015 the retail turnover volume (excluding the trade with motor vehicles and motor cycles), gross series, globally increased by 7.1% due to the increments registered by the retail of automotive fuel in specialised stores (+12.7%), by the sale of food, beverages and tobacco (+6.2%) and by the sale of non-food products (+4.9%).

As against the previous month, in April 2015 the retail turnover volume (excluding the trade with motor vehicles and motor cycles), adjusted series according to the number of working days and to seasonality, increased by 3.1% due to the increments registered by the sale of non-food products (+2.4%), by the retail of automotive fuel in specialised stores (+0.6%) and by the sale of food, beverages and tobacco (+0.3%).

April 2015 as against April 2014

As against April 2014, in April 2015 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), gross series, registered an increase of 7.1% due to the increments registered by the retail of automotive fuel in specialised stores (+14.9%), by the sale of food, beverages and tobacco (+10.8%) and by the sale of non-food products (+0.3%).

As against April 2014, in April 2015 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), adjusted series according to the number of working days and to seasonality, registered an increase of 7.5% due to the increments registered by the retail of automotive fuel in specialised stores (+13.4%), by the sale of food, beverages and tobacco (+8.9%) and by the sale of non-food products (+2.2%).

Period 1.I – 30.IV.2015 as against period 1.I – 30.IV.2014

As against period 1.I – 30.IV.2014, in the period 1.I – 30.IV.2015 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), gross series, registered an increase of 4.3% due to the increments registered by the sale of food, beverages and tobacco (+9.4%) and by the retail of automotive fuel in specialised stores (+6.8%). The sale of non-food products decreased by 0.9%.

As against period 1.I – 30.IV.2014, in the period 1.I – 30.IV.2015 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), adjusted series according to the number of working days and to seasonality, registered an increase of 4.4% due to the increments registered by the sale of food, beverages and tobacco (+8.2%), by the retail of automotive fuel in specialised stores (+5.2%) and by the sale of non-food products (+0.1%).
