




Domain: Trade and services

In April 2017, the retail turnover increased by 4.8% compared to April 2016

- Compared to the previous month, in April 2017 the retail turnover volume (excluding the trade with motor vehicles and motorcycles) increased as gross series by 2.6% and decreased as adjusted series according to the number of working days and to seasonality by 0.2%.
- Compared to the corresponding month of the previous year, the retail turnover volume (excluding the trade with motor vehicles and motorcycles) increased both as gross series and as adjusted series according to the number of working days and to seasonality by 4.8% and by 6.1%, respectively.
- Compared to the period 1.I-30.IV.2016, in the period 1.I-30.IV.2017 the retail turnover volume (excluding the trade with motor vehicles and motorcycles) increased both as gross series and as adjusted series according to the number of working days and to seasonality by 6.3% and by 7.0%, respectively.

April 2017 as against March 2017

As against the previous month, in April 2017 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), gross series, globally increased by 2.6% due to increments registered by the sale of food, beverages and tobacco (+6.5%) and by the sale of non-food products (+1.0%). The retail of automotive fuel in specialised stores decreased by 0.6%.

As against the previous month, in April 2017 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), adjusted series according to the number of working days and to seasonality, globally decreased by 0.2% due to the drops registered by the retail of automotive fuel in specialised stores (-3.3%) and by the sale of food, beverages and tobacco (-0.3%). The sale of non-food products increased by 0.7%.

April 2017 as against April 2016

As against April 2016, in April 2017, the retail turnover volume (excluding the trade with motor vehicles and motorcycles), gross series, registered an increase of 4.8% due to the increments registered by the sale of non-food products (+8.5%) and by the retail of automotive fuel in specialised stores (+6.7%). The sale of food, beverages and tobacco decreased by 0.1%.

As against April 2016, in April 2017, the retail turnover volume (excluding the trade with motor vehicles and motorcycles), adjusted series according to the number of working days and to seasonality, registered an increase of 6.1% due to the increments registered by the sale of non-food products (+9.7%), by the retail of automotive fuel in specialised stores (+7.9%) and by the sale of food, beverages and tobacco (+0.7%).

Period 1.I-30.IV.2017 as against period 1.I-30.IV.2016

As against the period 1.I-30.IV.2016, in the period 1.I-30.IV.2017 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), gross series, registered an increase of 6.3% due to the increments registered by the retail of automotive fuel in specialised stores (+10.9%), by the sale of non-food products (+8.9%) and by the sale of food, beverages and tobacco (+1.2%).

As against the period 1.I-30.IV.2016, in the period 1.I-30.IV.2017 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), adjusted series according to the number of working days and to seasonality, registered an increase of 7.0% due to the increments registered by the sale of non-food products (+10.1%), by the retail of automotive fuel in specialised stores (+9.6%) and by the sale of food, beverages and tobacco (+2.1%).
