

The retail turnover in April 2020

- Compared to the previous month, in April 2020 the retail turnover volume (excluding the trade with motor vehicles and motorcycles) decreased both as gross series by 19.7% and as adjusted series according to the number of working days and to seasonality by 22.3%.
- Compared to the corresponding month of the previous year, the retail turnover volume (excluding the trade with motor vehicles and motorcycles) decreased both as gross series by 19.5% and as adjusted series according to the number of working days and to seasonality by **18.5**%.
- Compared to the period 1.I-30.IV.2019, in the period 1.I-30.IV.2020 the retail turnover volume (excluding the trade with motor vehicles and motorcycles) increased both as gross series by 1.5% and as adjusted series according to the number of working days and to seasonality by 1.0%.

April 2020 as against March 2020

As against the previous month, in April 2020 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), gross series, globally decreased by 19.7% due to drops registered by the retail of automotive fuel in specialised stores (-31.4%), by the sale of non-food products (-20.5%) and by the sale of food, beverages and tobacco (-13.4%).

As against the previous month, in April 2020 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), adjusted series according to the number of working days and to seasonality, globally decreased by 22.3% due to the drops registered by the retail of automotive fuel in specialised stores (-35.1%), by the sale of non-food products (-22.3%) and by the sale of food, beverages and tobacco (-15.5%).

April 2020 as against April 2019

As against April 2019, in April 2020 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), gross series, registered a decrease of 19.5% due to the drops registered by the retail of automotive fuel in specialised stores (-38.4%), by the sale of non-food products (-22.9%) and by the sale of food, beverages and tobacco (-4.7%).

As against April 2019. in April 2020 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), adjusted series according to the number of working days and to seasonality, registered a decrease of 18.5% due to the drops registered by the retail of automotive fuel in specialised stores (-37.7%), by the sale of non-food products (-21.6%) and by the sale of food, beverages and tobacco (-5.0%).

Period 1.I-30.IV.2020 as against period 1.I-30.IV.2019

As against period 1.I-30.IVI.2019, in the period 1.I-30.IV.2020 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), gross series, registered an increase of 1.5% due to the increases registered by the sale of food, beverages and tobacco (+9.4%). Drops were registered by the retail of automotive fuel in specialised stores (-8.1%) and by the sale of non-food products (-0.6%).

As against period 1.I-30.IV.2019, in the period 1.I-30.IV.2020 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), adjusted series according to the number of working days and to seasonality, registered an increase of 1.0% due to the increases registered by the sale of food, beverages and tobacco (+8.0%). Drops were registered by the retail of automotive fuel in specialised stores (-7.3%) and by the sale of non-food products (-1.0%).

IMPORTANT!

- ✓ The information in this press release (April 2020) capture the impact of the COVID-19 crisis and of the measures taken by the authorities following the state of emergency decree on the Romanian territory starting with March 16, 2020.
- ✓ The National Institute of Statistics understands the difficulties faced by our respondents during this period and we are aware that the answers to the statistical surveys may not be a priority at present.
- ✓ However, by collecting statistical information, we will be able to monitor and inform all our users about the effects of COVID-19 on our economy and society.
- ✓ We appreciate the continued support of our respondents in the statistical surveys conducted by the National Institute of Statistics and understand the difficulties which all providers of statistical data are facing.

Additional information:

- ✓ The turnover represents the total revenue recorded by the company during the reporting period, obtained from both the main activity and the secondary activities performed by them. The turnover does not include VAT and the revenue from the sale or transfer of assets.
- ✓ The turnover volume indices of the retail are Laspeyres type indices and are calculated under comparable prices and methodological conditions. For expressing the values of the current period in prices of the reference period, the deflating price indices are used (consumer price index). The first indices obtained are at the level of class/group CANE Rev. 2, then, by successive aggregations, indices at aggregated levels are obtained. The weights used for aggregation are calculated based on the turnover according to the results of the Business Structural Survey from the reference year (2015).
- ✓ The response rate to the monthly statistical survey on short-term indicators in services (SERV TS), turnover chapter (CANE 47), was 75.2% in April 2020 compared to 80.7% in April 2019.
