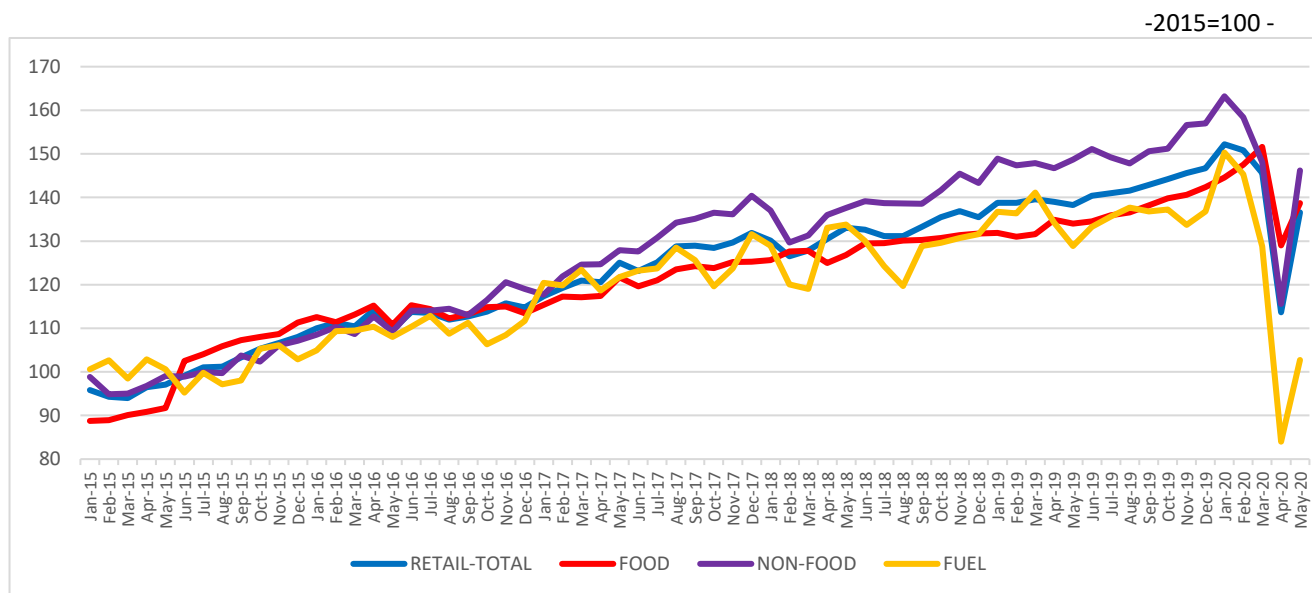

## The retail turnover in May 2020

- Compared to the previous month, in May 2020 **the retail turnover volume (excluding the trade with motor vehicles and motorcycles)** increased both as gross series by **18.5%** and as adjusted series according to the number of working days and to seasonality by **20.2%**.
- Compared to the corresponding month of the previous year, **the retail turnover volume (excluding the trade with motor vehicles and motorcycles)** decreased both as gross series by **5.3%** and as adjusted series according to the number of working days and to seasonality by **1.2%**.
- Compared to the period 1.I-31.V.2019, in the period 1.I-31.V.2020 **the retail turnover volume (excluding the trade with motor vehicles and motorcycles)** increased both as gross series by **0.1%** and as adjusted series according to the number of working days and to seasonality by **0.6%**.

#### May 2020 as against April 2020

As against the previous month, in May 2020 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), gross series, globally increased by 18.5% due to increases registered by the retail of automotive fuel in specialised stores (+29.5%), by the sale of non-food products (+28.2%) and by the sale of food, beverages and tobacco (+6.3%).

As against the previous month, in May 2020 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), adjusted series according to the number of working days and to seasonality, globally increased by 20.2% due to increases registered by the sale of non-food products (+26.5%), by the retail of automotive fuel in specialised stores (+22.3%) and by the sale of food, beverages and tobacco (+7.5%).

#### May 2020 as against May 2019

As against May 2019, in May 2020 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), gross series, globally decreased by 5.3% due to the drops registered by the retail of automotive fuel in specialised stores (-22.2%) and by the sale of non-food products (-5.2%). The sale of food, beverages and tobacco increased by 5.2%.

As against May 2019, in May 2020 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), adjusted series according to the number of working days and to seasonality, globally decreased of 1.2% due to the drops registered by the retail of automotive fuel in specialised stores (-20.4%) and by the sale of non-food products (-1.7%). The sale of food, beverages and tobacco increased by 3.5%.

## Period 1.I-31.V.2020 as against period 1.I-31.V.2019

As against period 1.I-31.V.2019, in the period 1.I-31.V.2020 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), gross series, registered an increase of 0.1% due to the increases registered by the sale of food, beverages and tobacco (+8.5%). Drops were registered by the retail of automotive fuel in specialised stores (-11.2%) and by the sale of non-food products (-1.6%).

As against period 1.I-31.V.2019, in the period 1.I-31.V.2020 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), adjusted series according to the number of working days and to seasonality, registered an increase of 0.6% due to the increases registered by the sale of food, beverages and tobacco (+7.3%). Drops were registered by the retail of automotive fuel in specialised stores (-9.8%) and by the sale of non-food products (-1.1%).

## Additional information:

- ✓ The turnover represents the total revenue recorded by the company during the reporting period, obtained from both the main activity and the secondary activities performed by them. The turnover does not include VAT and the revenue from the sale or transfer of assets.
- ✓ The turnover volume indices of the retail are Laspeyres type indices and are calculated under comparable prices and methodological conditions. For expressing the values of the current period in prices of the reference period, the deflating price indices are used (consumer price index). The first indices obtained are at the level of class/group CANE Rev. 2, then, by successive aggregations, indices at aggregated levels are obtained. The weights used for aggregation are calculated based on the turnover according to the results of the Business Structural Survey from the reference year (2015).
- ✓ The response rate to the monthly statistical survey on short-term indicators in services (SERV TS), turnover chapter (CANE 47), was 77.5% in May 2020 compared to 84.9% in May 2019.
