

The retail turnover in July 2023

- Compared to June 2023, in July 2023 the retail turnover volume (excluding the trade with motor vehicles and motorcycles) increased as gross series by 5.7% and as adjusted series according to the number of working days and to seasonality decreased by 0.3%.
- Compared to July 2022, in July 2023 the retail turnover volume (excluding the trade with motor vehicles and motorcycles) increased both as gross series by 0.7% and as adjusted series according to the number of working days and to seasonality by 1.2%.
- Compared to period 1.I-31.VII.2022, in the period 1.I-31.VII.2023 the retail turnover volume (excluding the trade with motor vehicles and motorcycles) increased both as gross series by 2.7% and as adjusted series according to the number of working days and to seasonality by 2.6%.

July 2023 as against June 2023

As against the previous month, in July 2023 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), gross series, globally increased by 5.7% due to the increases registered by the retail of automotive fuel in specialised stores (+10.5%), by the sale of food, beverages and tobacco (+5.5%) and by the sale of non-food products (+3.4%).

As against the previous month, in July 2023 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), adjusted series according to the number of working days and to seasonality, globally decreased by 0.3% due to the decreases registered by the retail of automotive fuel in specialised stores (-1.3%) and by the sale of food, beverages and tobacco (-0.6%). The sale of non-food products increased by 1.0%.

July 2023 as against July 2022


As against July 2022, in July 2023 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), gross series, globally increased by 0.7% due to the increases registered by the sale of non-food products (+5.3%). The retail of automotive fuel in specialised stores decreased by 5.2% and the sale of food, beverages and tobacco decreased by 0.6%.


As against July 2022, in July 2023 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), adjusted series according to the number of working days and to seasonality, globally increased by 1.2% due to the increases registered by the sale of non-food products (+5.4%) and by the sale of food, beverages and tobacco (+0.3%). The retail of automotive fuel in specialised stores decreased by 4.2%.

Period 1.I-31.VII.2023 as against period 1.I-31.VII.2022

As against period 1.I-31.VII.2022, in the period 1.I-31.VII.2023 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), gross series, globally increased by 2.7% due to the increases registered by the sale of non-food products (+4.4%) and by the sale of food, beverages and tobacco (+3.6%). The retail of automotive fuel in specialised stores decreased by 2.3%.

As against period 1.I-31.VII.2022, in the period 1.I-31.VII.2023 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), adjusted series according to the number of working days and to seasonality, globally increased by 2.6% due to the increases registered by the sale of non-food products (+4.1%) and by the sale of food, beverages and tobacco (+3.1%). The retail of automotive fuel in specialised stores decreased by 1.4%.





Additional information:

- ✓ The net turnover represents the total revenue recorded by the company during the reporting period, obtained from both the main activity and the secondary activities performed by it. The net turnover does not include the VAT and the revenue from the sale or transfer of assets.
- ✓ The turnover volume indices of retail are Laspeyres-type indices and are calculated under comparable price and methodological conditions. For expressing the values of the current period in the prices of the reference period, the deflating price indices are used (the consumer price index). The first indices obtained are at the CANE Rev. 2 class/group level; then, by successive aggregations, indices at aggregated levels are obtained. The weights used for aggregation are calculated based on the turnover according to the results of the Structural Business Survey from the reference year (2015).
