

THE RETAIL TURNOVER INCREASED BY 9.6%

- As against the previous month, in August 2015 **the retail turnover volume (excluding the trade with motor vehicles and motorcycles)** increased as gross series by **1.4%** and decreased as adjusted series according to the number of working days and to seasonality by **0.3%**.
- As against the corresponding month of the previous year, **the retail turnover volume (excluding the trade with motor vehicles and motorcycles)** increased both as gross series and as adjusted series according to the number of working days and to seasonality by **9.6%** and by **8.0%**, respectively.
- As against the period 1.I – 31.VIII.2014, in the period 1.I – 31.VIII.2015 **the retail turnover volume (excluding the trade with motor vehicles and motorcycles)**, increased both as gross series and as adjusted series according to the number of working days and to seasonality by **6.2%** and by **5.8%**, respectively.

August 2015 as against July 2015

As against the previous month, in August 2015 the retail turnover volume (excluding the trade with motor vehicles and motor cycles), gross series, globally increased by 1.4% due to the increments registered by the sale of food, beverages and tobacco (+4.6%) and by the sale of non-food products (+1.6%). The retail of automotive fuel in specialised stores decreased by 3.5%.

As against the previous month, in August 2015 the retail turnover volume (excluding the trade with motor vehicles and motor cycles), adjusted series according to the number of working days and to seasonality, globally decreased by 0.3% due to the drops registered by the retail of automotive fuel in specialised stores (-4.3%). Increases were registered by the sale of food, beverages and tobacco (+2.0%) and by the sale of non-food products (+0.1%).

August 2015 as against August 2014

As against August 2014, in August 2015 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), gross series, registered an increase of 9.6% due to the increments registered by the sale of food, beverages and tobacco (+24.2%), by the retail of automotive fuel in specialised stores (+3.0%) and by the sale of non-food products (+2.2%).

As against August 2014, in August 2015 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), adjusted series according to the number of working days and to seasonality, registered an increase of 8.0% due to the increments registered by the sale of food, beverages and tobacco (+25.0%), by the retail of automotive fuel in specialised stores (+2.6%) and by the sale of non-food products (+0.4%).

Period 1.I – 31.VIII.2015 as against period 1.I – 31.VIII.2014

As against the period 1.I – 31.VIII.2014, in the period 1.I – 31.VIII.2015 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), gross series, registered an increase of 6.2% due to the increments registered by the sale of food, beverages and tobacco (+14.8%) and by the retail of automotive fuel in specialised stores (+5.4%). The sale of non-food products remained at the same level.

As against the period 1.I – 31.VIII.2014, in the period 1.I – 31.VIII.2015 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), adjusted series according to the number of working days and to seasonality, registered an increase of 5.8% due to the increments registered by the sale of food, beverages and tobacco (+14.0%), by the retail of automotive fuel in specialised stores (+4.9%) and by the sale of non-food products (+0.3%).
