


Domain: Trade and services

In September 2016, the retail turnover increased by 9.7% compared to September 2015

- Compared to the previous month, in September 2016 the retail turnover volume (excluding the trade with motor vehicles and motorcycles) decreased as gross series by 3.3% and increased as adjusted series according to the number of working days and to seasonality by 0.1%.
- Compared to the corresponding month of the previous year, the retail turnover volume (excluding the trade with motor vehicles and motorcycles) increased both as gross series and as adjusted series according to the number of working days and to seasonality by 9.7% and by 11.1%, respectively.
- Compared to the period 1.I-30.IX.2015, in the period 1.I-30.IX.2016, the retail turnover volume (excluding the trade with motor vehicles and motorcycles) increased both as gross series and as adjusted series according to the number of working days and to seasonality by 15.5% and by 15.3%, respectively.

September 2016 as against August 2016

As against the previous month, in September 2016, the retail turnover volume (excluding the trade with motor vehicles and motorcycles), gross series, globally decreased by 3.3% due to the drops registered by the sale of food, beverages and tobacco (-4.7%), by the retail of automotive fuel in specialised stores (-4.0%) and by the sale of non-food products (-1.8%).

As against the previous month, in September 2016, the retail turnover volume (excluding the trade with motor vehicles and motorcycles), adjusted series according to the number of working days and to seasonality globally increased by 0.1% due to the increments registered by the retail of automotive fuel in specialised stores (+1.3%) and by the sale of food, beverages and tobacco (+0.4%). The sale of non-food products decreased by 1.8%.

September 2016 as against September 2015

As against September 2015, in September 2016, the retail turnover volume (excluding the trade with motor vehicles and motorcycles), gross series, registered an increase of 9.7% due to the increments registered by the retail of automotive fuel in specialised stores (+15.2%), by the sale of non-food products (+9.6%) and by the sale of food, beverages and tobacco (+6.3%).

As against September 2015, in September 2016, the retail turnover volume (excluding the trade with motor vehicles and motorcycles), adjusted series according to the number of working days and to seasonality, registered an increase of 11.1% due to the increments registered by the retail of automotive fuel in specialised stores (+15.7%), by the sale of non-food products (+10.4%) and by the sale of food, beverages and tobacco (+7.5%).

Period 1.I-30.IX.2016 as against period 1.I-30.IX.2015

As against period 1.I-30.IX.2015, in the period 1.I-30.IX.2016, the retail turnover volume (excluding the trade with motor vehicles and motorcycles), gross series, registered an increase of 15.5% due to the increments registered by the sale of food, beverages and tobacco (+17.8%), by the sale of non-food products (+15.3%) and by the retail of automotive fuel in specialised stores (+12.3%).

As against period 1.I-30.IX.2015, in the period 1.I-30.IX.2016, the retail turnover volume (excluding the trade with motor vehicles and motorcycles), adjusted series according to the number of working days and to seasonality, registered an increase of 15.3%, due to the increments registered by the sale of food, beverages and tobacco (+18.0%), by the sale of non-food products (+14.7%) and by the retail of automotive fuel in specialised stores (+11.8%).
