
Domain: Trade and services

In 2017, the retail turnover increased by 10.7% compared to 2016

- Compared to the previous month, in December 2017 the retail turnover volume (excluding the trade with motor vehicles and motorcycles) increased both as gross series by 7.0% and as adjusted series according to the number of working days and to seasonality by 1.3%.
- Compared to the corresponding month of the previous year, the retail turnover volume (excluding the trade with motor vehicles and motorcycles) increased both as gross series and as adjusted series according to the number of working days and to seasonality by 13.4% each.
- Compared to the period 2016, in 2017 the retail turnover volume (excluding the trade with motor vehicles and motorcycles) increased as gross series by 10.7%.

December 2017 as against November 2017

As against the previous month, in December 2017 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), gross series, globally increased by 7.0% due to the increases registered by the sale of food, beverages and tobacco (+15.7%) and by the sale of non-food products (+6.5%). The retail of automotive fuel in specialised stores decreased by 5.6%.

As against the previous month, in December 2017 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), adjusted series according to the number of working days and to seasonality, globally increased by 1.3% due to the increases registered by the retail of automotive fuel in specialised stores (+6.5%) and by the sale of non-food products (+4.2%). Drops were registered by the sale food, beverages and tobacco (-0.2%).

December 2017 as against December 2016

As against December 2016, in December 2017 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), gross series, registered an increase of 13.4% due to the increases registered by the sale of non-food products (+15.5%), by the retail of automotive fuel in specialised stores (+14.5%) and by the sale of food, beverages and tobacco (+10.3%).

As against December 2016, in December 2017 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), adjusted series according to the number of working days and to seasonality, registered an increase of 13.4% due to the increases registered by the retail of automotive fuel in specialised stores (+18.7%), by the sale of non-food products (+15.8%) and by the sale of food, beverages and tobacco (+11.7%).

Year 2017 as against year 2016

As against 2016, in the period 2017 the retail turnover volume (excluding the trade with motor vehicles and motorcycles), gross series, registered an increase of 10.7% due to the increases registered by the sale of non-food products (+13.2%), by the retail of automotive fuel in specialised stores (+12.4%) and by the sale of food, beverages and tobacco (+6.8%).

Additional information:

- ✓ The turnover represents the total revenue recorded by the company during the reporting period, obtained from both the main activity and the secondary activities performed by them. The turnover does not include VAT and the revenue from the sale or transfer of assets.
- ✓ The turnover volume indices of the retail are Laspeyres type indices and are calculated under comparable prices and methodological conditions. For expressing the values of the current period in prices of the reference period, the deflating price indices are used (consumer price index). The first indices obtained are at the level of class/group CANE Rev. 2, then, by successive aggregations, indices at aggregated levels are obtained. The weights used for aggregation are calculated based on the turnover according to the results of the Business Structural Survey from the reference year (2010).
