

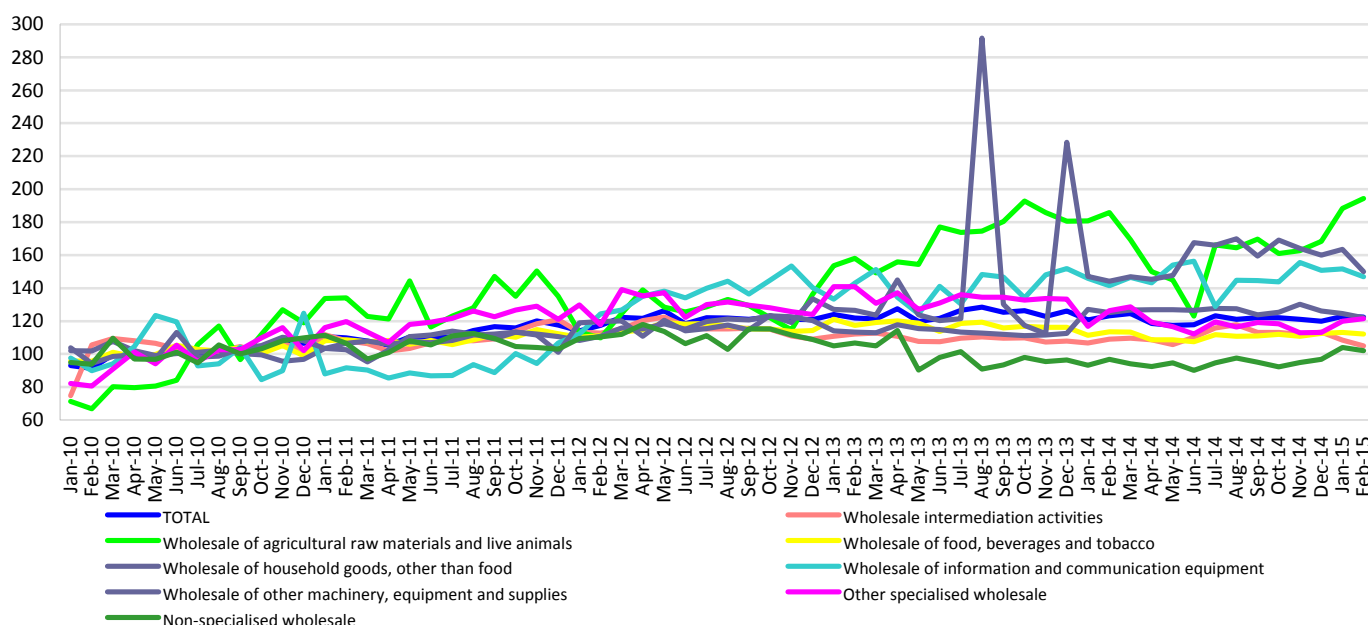

## THE WHOLESALE TURNOVER DECREASED BY 0.6%

- As against the previous month, in February 2015 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, in nominal terms, increased as gross series by **9.0%** and decreased as adjusted series according to the number of working days and to seasonality by **0.3%**.
- As against the corresponding month of the previous year, **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, in nominal terms, decreased both as gross series and as adjusted series according to the number of working days and to seasonality by **0.6%** and by **0.7%**, respectively.
- As against the period 1.I-28.II.2014, in the period 1.I-28.II.2015 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, in nominal terms, increased both as gross series by **0.4%** and as adjusted series according to the number of working days and to seasonality by **0.5%**.

### February 2015 as against January 2015

As against the previous month, in February 2015 the wholesale turnover (excluding the trade with motor vehicles and motor cycles), gross series, in nominal terms, globally increased by 9.0% due to the increments registered by the wholesale of agricultural raw materials and live animals (+27.4%), by the other specialised wholesale (+23.1%), by the non-specialised wholesale (+8.7%), by the wholesale of households goods, other than food (+4.1%), by the wholesale of food, beverages and tobacco (+4.0%), by the wholesale of information and communication equipment (+3.2%). Drops were registered by the wholesale of other machinery, equipment and supplies (-10.5%) and by the wholesale intermediation activities (-2.4%).

As against the previous month, in February 2015 the wholesale turnover (excluding the trade with motor vehicles and motor cycles), adjusted series according to the number of working days and to seasonality, in nominal terms, decreased by 0.3% due to the drops registered by the wholesale of other machinery, equipment and supplies (-8.2%), by the wholesale intermediation activities (-3.3%), by the wholesale of information and communication equipment (-3.1%), by the non-specialised wholesale (-1.9%), by the wholesale of household goods, other than food (-1.9%) and by the wholesale of food, beverages and tobacco (-0.9%). Increases were registered by the wholesale of agricultural raw materials and live animals (+3.2%) and by the other specialised wholesale (+1.1%).

## February 2015 as against February 2014

As against February 2014, in February 2015 the wholesale turnover (excluding the trade with motor vehicles and motorcycles), gross series, in nominal terms, registered a decrease of 0.6% due to the drops registered by the wholesale intermediation activities (-7.1%), by the wholesale of households goods, other than food (-3.2%), by the other specialised wholesale (-2.3%), by the wholesale of other machinery, equipment and supplies (-1.6%) and by the wholesale of food, beverages and tobacco (-1.5%). Increases were registered by the wholesale of agricultural raw materials and live animals (+9.9%), by the non-specialised wholesale (+8.5%) and by the wholesale of information and communication equipment (+3.2%).

As against February 2014, in February 2015 the wholesale turnover (excluding the trade with motor vehicles and motorcycles), adjusted series according to the number of working days and to seasonality, in nominal terms, registered a decrease of 0.7% due to the drops registered by the other specialised wholesale (-3.9%), by the wholesale intermediation activities (-3.7%), by the wholesale of households goods, other than food (-2.3%) and by the wholesale of food, beverages and tobacco (-1.3%). Increases were registered by the non-specialised wholesale (+5.5%), by the wholesale of agricultural raw materials and live animals (+4.6%), by the wholesale of other machinery, equipment and supplies (+4.1%) and by the wholesale of information and communication equipment (+3.8%).

## Period 1.I-28.II-2015 as against period 1.I-28.II-2014

As against period 1.I-28.II-2014, in the period 1.I-28.II-2015 the wholesale turnover (excluding the trade with motor vehicles and motorcycles), gross series, in nominal terms, registered an increase of 0.4% due to the increments registered by the non-specialised wholesale (+9.5%), by the wholesale of agricultural raw materials and live animals (+9.2%), by the wholesale of other machinery, equipment and supplies (+4.6%) and by the wholesale of information and communication equipment (+1.7%). Drops were registered by the wholesale of households goods, other than food (-3.6%), by the wholesale intermediation activities (-3.0%), by the other specialised wholesale (-0.7%) and by the wholesale of food, beverages and tobacco (-0.4%).

As against period 1.I-28.II-2014, in the period 1.I-28.II-2015 the wholesale turnover (excluding the trade with motor vehicles and motorcycles), adjusted series according to the number of working days and to seasonality, in nominal terms, registered an increase of 0.5% due to the increments registered by the non-specialised wholesale (+8.5%), by the wholesale of other machinery, equipment and supplies (+7.6%), by the wholesale of agricultural raw materials and live animals (+4.3%), by the wholesale of information and communication equipment (+3.8%) and by the wholesale of food, beverages and tobacco (+0.2%). Drops were registered by the wholesale of households goods, other than food (-2.2%), by the wholesale intermediation activities (-1.0%) and by the other specialised wholesale (-0.7%).
