

Domain: Trade - services

In February 2017, the wholesale turnover increased by 0.6% compared to February 2016

- As against the previous month, in February 2017 the **wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, in nominal terms, increased as gross series by **12.8%** and decreased as adjusted series according to the number of working days and to seasonality by **0.1%**.
- As against the corresponding month of the previous year, **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, in nominal terms, increased both as gross series by **0.6%** and as adjusted series according to the number of working days and to seasonality by **2.5%**.
- As against the period 1.I-29.II.2016, in the period 1.I-28.II.2017 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, in nominal terms, increased both as gross series and as adjusted series according to the number of working days and to seasonality by **2.6%** and by **4.0%**, respectively.

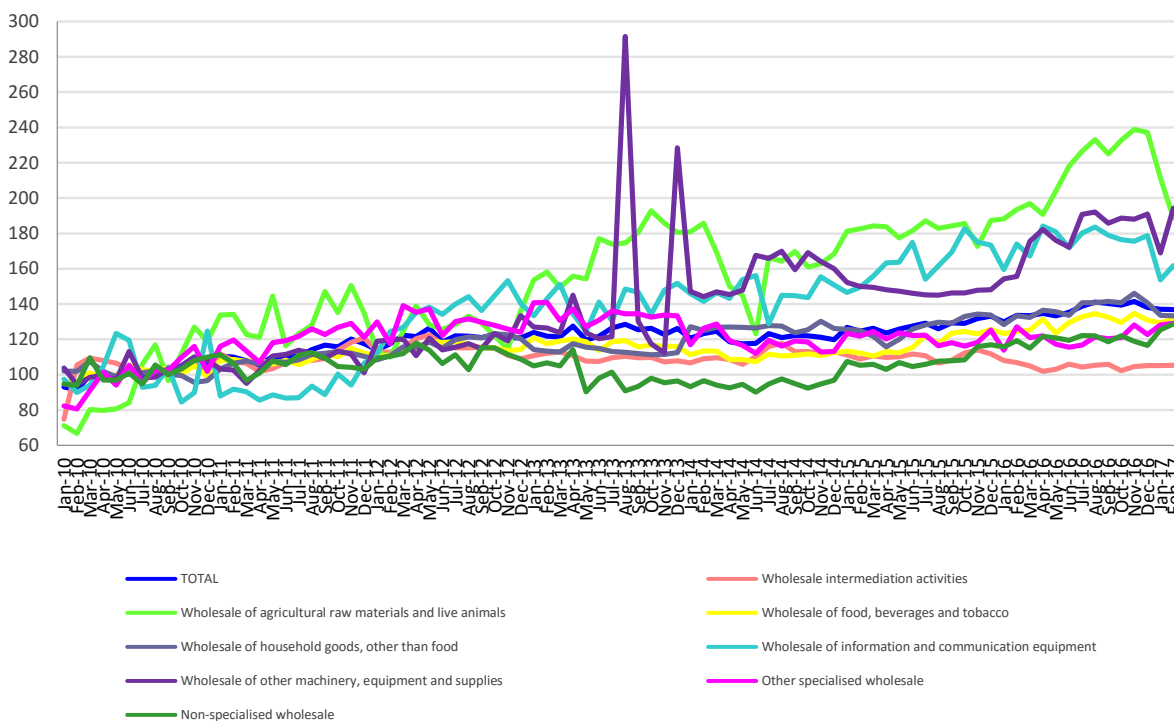

February 2017 as against January 2017

As against the previous month, in February 2017 the **wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, gross series, in nominal terms, globally increased by 12.8% due to the increments registered by the other specialised wholesale (+31.2%), by the wholesale of other machinery, equipment and supplies (+22.6%), by the non-specialised wholesale (+17.5%), by the wholesale of information and communication equipment (+11.8%), by the wholesale of food, beverages and tobacco (+8.1%), by the wholesale of household goods, other than food (+7.1%), by the wholesale intermediation activities (+4.1%) and by the wholesale of agricultural raw materials and live animals (+2.1%).

As against the previous month, in February 2017 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, adjusted series according to the number of working days and to seasonality, in nominal terms, globally decreased by 0.1% due to the drops registered by the wholesale of agricultural raw materials and live animals (-10.7%) and by the wholesale of household goods, other than food (-0.2%). Increases were registered by the wholesale of other machinery, equipment and supplies (+15.0%), by the wholesale of information and communication equipment (+5.2%), by the non-specialised wholesale (+2.6%), by the wholesale of food, beverages and tobacco (+1.7%), by the other specialised wholesale (+0.6%) and by the wholesale intermediation activities (+0.2%).

February 2017 as against February 2016

As against February 2016, in February 2017 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, gross series, in nominal terms, registered an increase of 0.6% due to the increments registered by the non-specialised wholesale (+7.9%), by the other specialised wholesale (+6.0%) and by the wholesale of food, beverages and tobacco (+5.3%). Drops were registered by the wholesale of agricultural raw materials and live animals (-11.2%), by the wholesale of information and communication equipment (-4.1%), by the wholesale of other machinery, equipment and supplies (-3.9%), by the wholesale intermediation activities (-3.8%) and by the wholesale of household goods, other than food (-2.9%).

As against February 2016, in February 2017 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, adjusted series according to the number of working days and to seasonality, in nominal terms, registered an increase of 2.5% due to the increments registered by the wholesale of other machinery, equipment and supplies (+24.8%), by the non-specialised wholesale (+7.9%), by the wholesale of food, beverages and tobacco (+5.6%), by the other specialised wholesale (+1.5%) and by the wholesale of household goods, other than food (+0.1%). Drops were registered by the wholesale of information and communication equipment (-7.1%), by the wholesale of agricultural raw materials and live animals (-2.5%) and by the wholesale intermediation activities (-1.4%).

Period 1.I-28.II.2017 as against period 1.I-29.II.2016

As against period 1.I-29.II.2016, in the period 1.I-28.II.2017 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, gross series, in nominal terms, registered an increase of 2.6% due to the increments registered by the other specialised wholesale (+9.3%), by the non-specialised wholesale (+8.3%) and by the wholesale of food, beverages and tobacco (+4.7%). Drops were registered by the wholesale of information and communication equipment (-4.9%), by the wholesale intermediation activities (-3.5%), by the wholesale of other machinery, equipment and supplies (-2.6%), by the wholesale of agricultural raw materials and live animals (-2.2%) and by the wholesale of household goods, other than food (-0.2%).

As against period 1.I-29.II.2016, in the period 1.I-28.II.2017 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, adjusted series according to the number of working days and to seasonality, in nominal terms, registered an increase of 4.0% due to the increments registered by the wholesale of other machinery, equipment and supplies (+17.2%), by the non-specialised wholesale (+8.1%), by the other specialised wholesale (+6.8%), by the wholesale of food, beverages and tobacco (+5.3%), by the wholesale of agricultural raw materials and live animals (+4.8%) and by the wholesale of household goods, other than food (+2.1%). Drops were registered by the wholesale of information and communication equipment (-5.4%) and by the wholesale intermediation activities (-2.0%).
