## THE WHOLESALE TURNOVER INCREASED IN QUARTER I 2015 BY 1.3%

- As against the previous month, in March 2015 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, in nominal terms, increased both as gross series by **20.1%** and as adjusted series according to the number of working days and to seasonality by **1.6%**.
- As against the corresponding month of the previous year, **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, in nominal terms, increased both as gross series and as adjusted series according to the number of working days and to seasonality by **2.2%** and by **0.4%**, respectively.
- As against quarter I 2014, in quarter I 2015 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, in nominal terms, increased both as gross series by **1.3%** and as adjusted series according to the number of working days and to seasonality by **0.7%**.

-2010=100 -

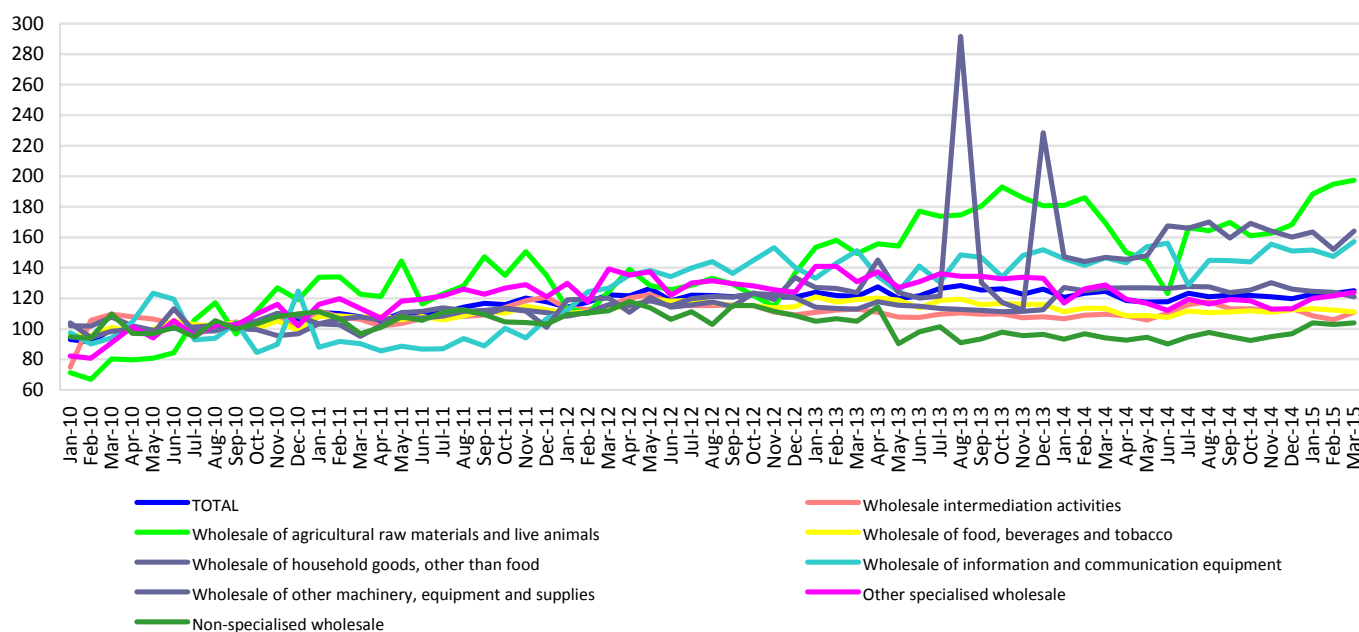

### March 2015 as against February 2015

As against the previous month, in March 2015 the **wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, gross series, in nominal terms, globally increased by 20.1% due to the increments registered by the other specialised wholesale (+38.8%), by the wholesale of other machinery, equipment and supplies (+34.4%), by the wholesale of information and communication equipment (+28.4%), by the wholesale of food, beverages and tobacco (+19.6%), by the non-specialised wholesale (+19.4%), by the wholesale intermediation activities (+17.1%), by the wholesale of households goods, other than food (+6.2%) and by the wholesale of agricultural raw materials and live animals (+3.7%).

As against the previous month, in March 2015 the **wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, adjusted series according to the number of working days and to seasonality, in nominal terms, increased by 1.6% due to the drops registered by the wholesale of other machinery, equipment and supplies (+8.0%), by the wholesale of information and communication equipment (+6.8%), by the wholesale intermediation activities (+4.5%), by the other specialised wholesale (+1.9%), by the wholesale of agricultural raw materials and live animals (+1.3%) and by the non-specialised wholesale (+1.2%). Drops were registered by the wholesale of household goods, other than food (-2.2%) and by the wholesale of food, beverages and tobacco (-1.0%).

## March 2015 as against March 2014

As against March 2014, in March 2015 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, gross series, in nominal terms, registered an increase of 2.2% due to the increments registered by the wholesale of agricultural raw materials and live animals (+23.2%), by the non-specialised wholesale (+14.8%), by the wholesale of information and communication equipment (+11.8%) and by the wholesale of other machinery, equipment and supplies (+8.0%). Drops were registered by the wholesale of households goods, other than food (-4.4%), by the wholesale of food, beverages and tobacco (-1.2%), by the wholesale intermediation activities (-0.4%) and by the other specialised wholesale (-0.3%).

As against March 2014, in March 2015 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, adjusted series according to the number of working days and to seasonality, in nominal terms, registered an increase of 0.4% due to the increments registered by the wholesale of agricultural raw materials and live animals (+16.6%), by the wholesale of other machinery, equipment and supplies (+11.8%), by the non-specialised wholesale (+10.5%), by the wholesale of information and communication equipment (+7.4%) and by the wholesale intermediation activities (+1.1%). Drops were registered by the wholesale of households goods, other than food (-4.4%), by the other specialised wholesale (-3.6%) and by the wholesale of food, beverages and tobacco (-2.0%).

## Quarter I 2015 as against quarter I 2014

As against quarter I 2014, in quarter I 2015 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, gross series, in nominal terms, registered an increase of 1.3% due to the increments registered by the wholesale of agricultural raw materials and live animals (+13.9%), by the non-specialised wholesale (+11.6%), by the wholesale of other machinery, equipment and supplies (+6.0%) and by the wholesale of information and communication equipment (+5.4%). Drops were registered by the wholesale of households goods, other than food (-3.2%), by the wholesale intermediation activities (-1.7%), by the other specialised wholesale (-0.6%) and by the wholesale of food, beverages and tobacco (-0.6%).

As against quarter I 2014, in quarter I 2015 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, adjusted series according to the number of working days and to seasonality, in nominal terms, registered an increase of 0.7% due to the increments registered by the wholesale of other machinery, equipment and supplies (+9.5%), by the non-specialised wholesale (+9.4%), by the wholesale of agricultural raw materials and live animals (+8.3%), by the wholesale of information and communication equipment (+5.1%) and by the wholesale intermediation activities (+0.1%). Drops were registered by the wholesale of households goods, other than food (-2.5%), by the other specialised wholesale (-1.6%) and by the wholesale of food, beverages and tobacco (-0.5%).
