THE WHOLESALE TURNOVER DECREASED BY 0.3%

- As against the previous month, in April 2015 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, in nominal terms, decreased both as gross series by **8.1%** and as adjusted series according to the number of working days and to seasonality by **2.7%**.
- As against the corresponding month of the previous year, **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, in nominal terms, decreased as gross series by **0.3%** and increased as adjusted series according to the number of working days and to seasonality by **2.1%**.
- As against the 1.I-30.IV.2014 period, in the 1.I-30.IV.2015 period **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, in nominal terms, increased both as gross series by **0.8%** and as adjusted series according to the number of working days and to seasonality by **0.9%**.

-2010=100 -

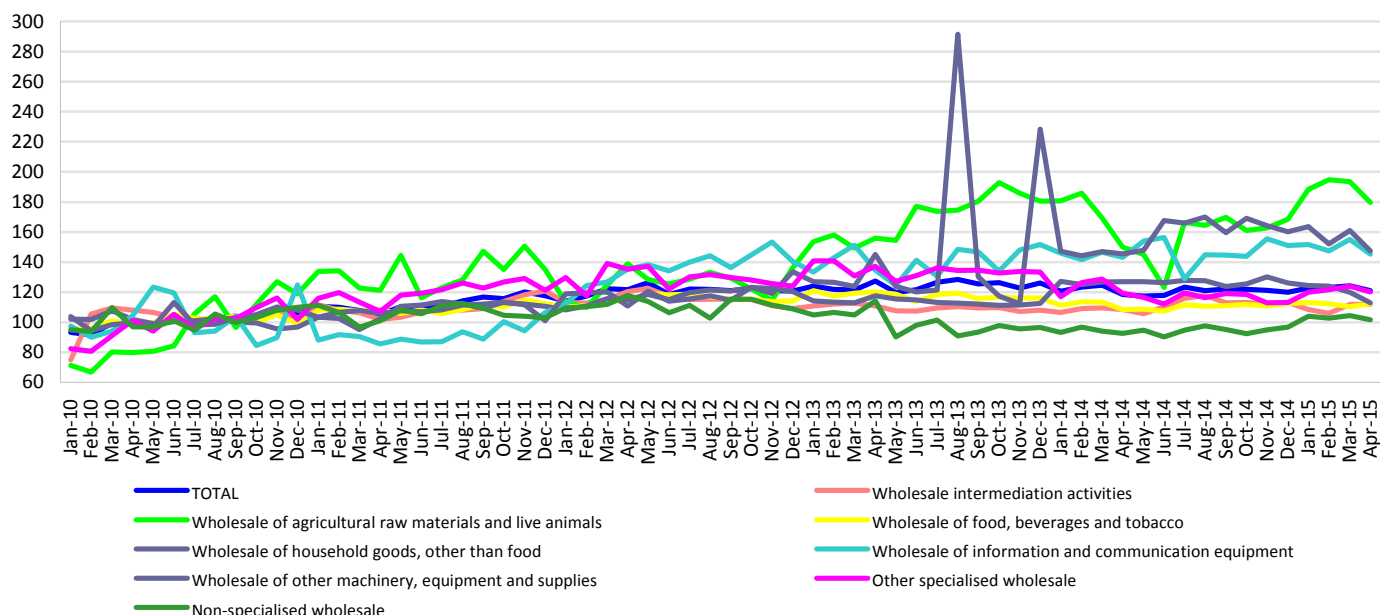

April 2015 as against March 2015

As against the previous month, in April 2015 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, gross series, in nominal terms, globally decreased by 8.1% due to the drops registered by the wholesale of information and communication equipment (-19.7%), by the wholesale of agricultural raw materials and live animals (-16.0%), by the other specialised wholesale (-11.5%), by the wholesale of household goods, other than food (-10.8%), by the wholesale of other machinery, equipment and supplies (-10.0%), by the non-specialised wholesale (-6.8%) and by the wholesale intermediation activities (-4.8%). An increment was registered by the wholesale of food, beverages and tobacco (+2.5%).

As against the previous month, in April 2015 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, adjusted series according to the number of working days and to seasonality, in nominal terms, decreased by 2.7% due to the drops registered by the wholesale of other machinery, equipment and supplies (-8.4%), by the wholesale of agricultural raw materials and live animals (-7.1%), by the wholesale of information and communication equipment (-6.3%), by the wholesale of household goods, other than food (-5.8%), by the other specialised wholesale (-3.1%) and by the non-specialised wholesale (-2.8%). Increments were registered by the wholesale of food, beverages and tobacco (+1.9%) and by the wholesale intermediation activities (+0.1%).

April 2015 as against April 2014

As against April 2014, in April 2015 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, gross series, in nominal terms, registered a decrease of 0.3% due to the drops registered by the wholesale of household goods, other than food (-13.0%), by the wholesale of other machinery, equipment and supplies (-4.1%), by the wholesale intermediation activities (-1.9%) and by the other specialised wholesale (-0.7%). Increments were registered by the wholesale of agricultural raw materials and live animals (+17.0%), by the non-specialised wholesale (+8.7%), by the wholesale of information and communication equipment (+8.6%) and by the wholesale of food, beverages and tobacco (+2.6%).

As against April 2014, in April 2015 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, adjusted series according to the number of working days and to seasonality, in nominal terms, registered an increase of 2.1% due to the increments registered by the wholesale of agricultural raw materials and live animals (+19.8%), by the non-specialised wholesale (+9.8%), by the wholesale of food, beverages and tobacco (+3.5%), by the wholesale intermediation activities (+3.1%), by the wholesale of information and communication equipment (+1.5%), by the wholesale of other machinery, equipment and supplies (+1.4%) and by the other specialised wholesale (+0.6%). A drop was registered by the wholesale of household goods, other than food (-11.0%).

The 1.I-30.IV.2015 period as against the 1.I-30.IV.2014 period

As against the 1.I-30.IV.2014 period, in the 1.I-30.IV.2015 period **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, gross series, in nominal terms, registered an increase of 0.8% due to the increments registered by the wholesale of agricultural raw materials and live animals (+14.5%), by the non-specialised wholesale (+11.1%), by the wholesale of information and communication equipment (+5.9%) and by the wholesale of other machinery, equipment and supplies (+3.1%). Drops were registered by the wholesale of household goods, other than food (-5.8%), by the wholesale intermediation activities (-1.5%) and by the other specialised wholesale (-0.6%). The wholesale of food, beverages and tobacco stayed at the same level.

As against the 1.I-30.IV.2014 period, in the 1.I-30.IV.2015 period **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, adjusted series according to the number of working days and to seasonality, in nominal terms, registered an increase of 0.9% due to the increments registered by the wholesale of agricultural raw materials and live animals (+10.3%), by the non-specialised wholesale (+9.7%), by the wholesale of other machinery, equipment and supplies (+6.9%), by the wholesale of information and communication equipment (+3.8%), by the wholesale intermediation activities (+1.1%) and by the wholesale of food, beverages and tobacco (+0.3%). Drops were registered by the wholesale of household goods, other than food (-4.9%), and by the other specialised wholesale (-1.1%).
