IN THE PERIOD 1.I-31.V.2015, THE WHOLESALE TURNOVER INCREASED BY 0.7%

- As against the previous month, in May 2015 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, in nominal terms, decreased both as gross series by **2.9%** and as adjusted series according to the number of working days and to seasonality by **0.1%**.
- As against the corresponding month of the previous year, **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, in nominal terms, decreased as gross series by **0.2%** and increased as adjusted series according to the number of working days and to seasonality by **3.2%**.
- As against the period 1.I-31.V.2014, in the period 1.I-31.V.2015 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, in nominal terms, increased both as gross series by **0.7%** and as adjusted series according to the number of working days and to seasonality by **1.4%**.

-2010=100 -

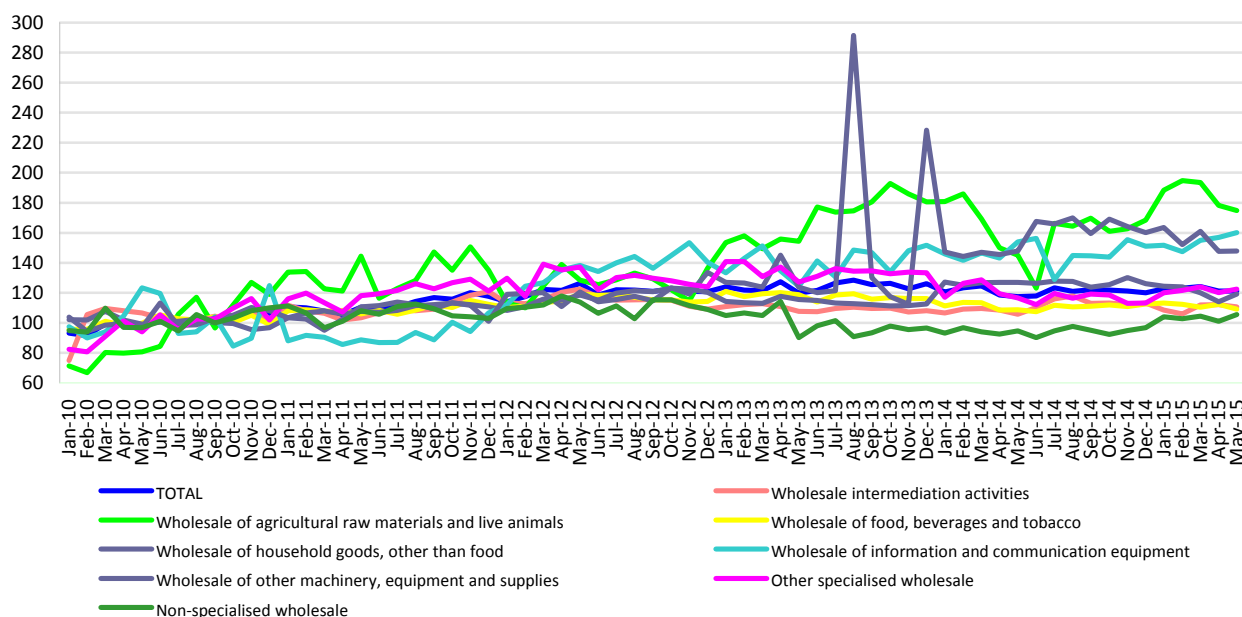

May 2015 as against April 2015

As against the previous month, in May 2015 the **wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, gross series, in nominal terms, globally decreased by 2.9% due to the drops registered by the wholesale of agricultural raw materials and live animals (-30.0%), by the wholesale intermediation activities (-5.5%), by the wholesale of information and communication equipment (-3.1%), by the wholesale of food, beverages and tobacco (-2.8%), by the non-specialised wholesale (-1.1%) and by the wholesale of other machinery, equipment and supplies (-0.8%). Increments were registered by the wholesale of household goods, other than food (+2.8%) and by the other specialised wholesale (+2.5%).

As against the previous month, in May 2015 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, adjusted series according to the number of working days and to seasonality, in nominal terms, decreased by 0.1% due to the drops registered by the wholesale of food, beverages and tobacco (-2.8%), by the wholesale of agricultural raw materials and live animals (-1.9%) and by the wholesale intermediation activities (-1.3%). Increments were registered by the wholesale of household goods, other than food (+4.4%), by the non-specialised wholesale (+4.3%), by the wholesale of information and communication equipment (+2.1%), by the other specialised wholesale (+1.9%) and by the wholesale of other machinery, equipment and supplies (+0.1%).

May 2015 as against May 2014

As against May 2014, in May 2015 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, gross series, in nominal terms, registered a decrease of 0.2% due to the increments registered by the wholesale of household goods, other than food (-9.7%), by the wholesale of other machinery, equipment and supplies (-5.6%), by the wholesale intermediation activities (-1.7%) and by the wholesale of food, beverages and tobacco (-1.6%). Increments were registered by the wholesale of information and communication equipment (+10.8%), by the wholesale of agricultural raw materials and live animals (+10.4%), by the non-specialised wholesale (+8.4%) and by the other specialised wholesale (+4.3%).

As against May 2014, in May 2015 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, adjusted series according to the number of working days and to seasonality, in nominal terms, registered an increase of 3.2% due to the increments registered by the wholesale of agricultural raw materials and live animals (+20.6%), by the non-specialised wholesale (+11.4%), by the other specialised wholesale (+5.1%), by the wholesale intermediation activities (+4.5%), by the wholesale of information and communication equipment (+4.1%) and by the wholesale of food, beverages and tobacco (+0.4%). The wholesale of household goods, other than food decreased by 6.2% and the wholesale of other machinery, equipment and supplies remained constant.

Period 1.I-31.V.2015 as against period 1.I-31.V.2014

As against period 1.I-31.V.2014, in the period 1.I-31.V.2015 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, gross series, in nominal terms, registered an increase of 0.7% due to the increments registered by the wholesale of agricultural raw materials and live animals (+13.8%), by the non-specialised wholesale (+10.7%), by the wholesale of information and communication equipment (+8.9%), by the wholesale of other machinery, equipment and supplies (+1.2%) and by the other specialised wholesale (+0.4%). Drops were registered by the wholesale of household goods, other than food (-6.4%), by the wholesale intermediation activities (-1.5%) and by the wholesale of food, beverages and tobacco (-0.3%).

As against period 1.I-31.V.2014, in the period 1.I-31.V.2015 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, adjusted series according to the number of working days and to seasonality, in nominal terms, registered an increase of 1.4% due to the increments registered by the wholesale of agricultural raw materials and live animals (+11.9%), by the non-specialised wholesale (+9.9%), by the wholesale of other machinery, equipment and supplies (+5.5%), by the wholesale of information and communication equipment (+5.5%), by the wholesale intermediation activities (+1.7%) by the wholesale of food, beverages and tobacco (+0.3%) and by the other specialised wholesale (+0.1%). The wholesale of household goods, other than food decreased by 5.0%.
