# THE WHOLESALE TURNOVER INCREASED BY 5.9%

- As against the previous month, in July 2015 the wholesale turnover (excluding the trade with motor vehicles and motorcycles), in nominal terms, increased both as gross series by 10.7% and as adjusted series according to the number of working days and to seasonality by 2.2%.
- As against the corresponding month of the previous year, the wholesale turnover (excluding the trade with motor vehicles and motorcycles), in nominal terms, increased both as gross series by 5.9% and as adjusted series according to the number of working days and to seasonality by 4.8%.
- As against the period 1.I-31.VII.2014, in the period 1.I-31.VII.2015 the wholesale turnover (excluding the trade with motor vehicles and motorcycles), in nominal terms, increased both as gross series by 2.8% and as adjusted series according to the number of working days and to seasonality by 2.9%.

- January 2010 - July 2015 -



# July 2015 as against June 2015

As against the previous month, in July 2015 the **wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, gross series, in nominal terms, globally increased by 10.7% due to the increments registered by the wholesale of agricultural raw materials and live animals (+103.3%), by the wholesale of food, beverages and tobacco (+8.0%), by the wholesale intermediation activities (+7.3%), by the other specialised wholesale (+7.2%), by the non-specialised wholesale (+5.6%) and by the wholesale of household goods, other than food (+5.1%). Drops were registered by the wholesale of information and communication equipment (-25.4%) and by the wholesale of other machinery, equipment and supplies (-14.8%).

As against the previous month, in July 2015 the wholesale turnover (excluding the trade with motor vehicles and motorcycles), adjusted series according to the number of working days and to seasonality, in nominal terms, increased by 2.2% due to the increments registered by the wholesale of food, beverages and tobacco (+5.2%), by the wholesale of household goods, other than food (+3.8%), by the wholesale of agricultural raw materials and live animals (+2.4%) and by the non-specialised wholesale (+2.3%). Drops were registered by the wholesale of information and communication equipment (-11.9%), by the wholesale of other machinery, equipment and supplies (-5.5%), by the wholesale intermediation activities and by the other specialised wholesale (-0.2% each).

## July 2015 as against July 2014

As against July 2014, in July 2015 the wholesale turnover (excluding the trade with motor vehicles and motorcycles), gross series, in nominal terms, registered an increase of 5.9% due to the increments registered by the wholesale of agricultural raw materials and live animals (+17.1%), by the wholesale of information and communication equipment (+16.3%), by the non-specialised wholesale (+10.7%), by the wholesale of food, beverages and tobacco (+10.5%), by the other specialised wholesale (+3.1%) and by the wholesale of household goods, other than food (+2.5%). Drops were registered by the wholesale of other machinery, equipment and supplies (-17.6%) and by the wholesale intermediation activities (-1.4%).

As against July 2014, in July 2015 the wholesale turnover (excluding the trade with motor vehicles and motorcycles), adjusted series according to the number of working days and to seasonality, in nominal terms, registered an increase of 4.8% due to the increments registered by the wholesale of information and communication equipment (+19.1%), by the wholesale of agricultural raw materials and live animals (+9.2%), by the wholesale of food, beverages and tobacco (+8.8%), by the non-specialised wholesale (+8.1%), by the other specialised wholesale (+2.9%) and by the wholesale of household goods, other than food (+0.8%). Drops were registered by the wholesale of other machinery, equipment and supplies (-14.5%) and by the wholesale intermediation activities (-2.8%).

# Period 1.I-31.VII.2015 as against period 1.I-31.VII.2014

As against the period 1.I-31.VII.2014, in the period 1.I-31.VII.2015 the wholesale turnover (excluding the trade with motor vehicles and motorcycles), gross series, in nominal terms, registered an increase of 2.8% due to the increments registered by the wholesale of agricultural raw materials and live animals (+19.0%), by the non-specialised wholesale (+11.6%), by the wholesale of information and communication equipment (+11.2%), by the wholesale of food, beverages and tobacco (+2.8%) and by the other specialised wholesale (+2.3%). Drops were registered by the wholesale of household goods, other than food and by the wholesale of other machinery, equipment and supplies (-4.3% each) as well as by the wholesale intermediation activities (-1.1%).

As against the period 1.I-31.VII.2014, in the period 1.I-31.VII.2015 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, adjusted series according to the number of working days and to seasonality, in nominal terms, registered an increase of 2.9% due to the increments registered by the wholesale of agricultural raw materials and live animals (+14.8%), by the non-specialised wholesale (+9.3%), by the wholesale of information and communication equipment (+8.4%), by the wholesale of food, beverages and tobacco (+2.8%), by the other specialised wholesale (+1.9%) and by the wholesale intermediation activities (+1.1%). Drops were registered by the wholesale of household goods, other than food (-3.7%) and by the wholesale of other machinery, equipment and supplies (-0.1%).
