

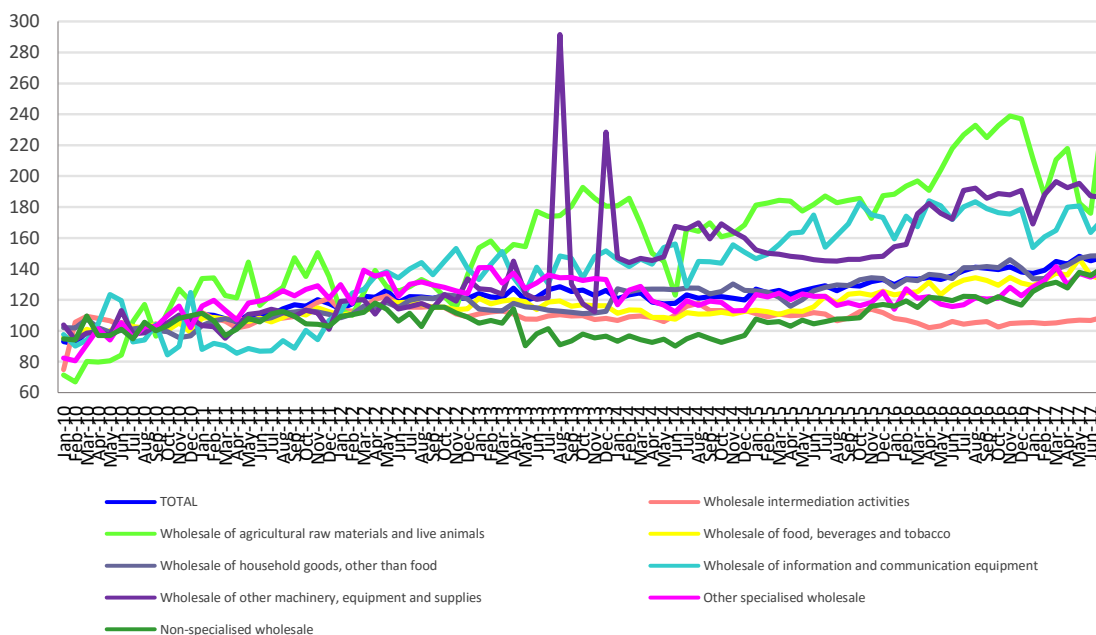
Domain: Trade - services

In July 2017, the wholesale turnover¹ increased by 1.6% compared to the previous month

- As against the previous month, in July 2017 the **wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, in nominal terms, increased both as gross series by **13.6%** and as adjusted series according to the number of working days and to seasonality by **1.6%**.
- As against the corresponding month of the previous year, **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, in nominal terms, increased both as gross series by **7.6%** and as adjusted series according to the number of working days and to seasonality by **6.2%**.
- As against the period 1.I-31.VII.2016, in the period 1.I-31.VII.2017 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, in nominal terms, increased both as gross series and as adjusted series according to the number of working days and to seasonality by **6.5%** and by **7.0%**, respectively.

July 2017 as against June 2017

As against the previous month, in July 2017 the **wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, gross series, in nominal terms, globally increased by 13.6% due to the increases registered by the wholesale of agricultural raw materials and live animals (+201.2%), by the other specialised wholesale (+9.0%), by the non-specialised wholesale (+8.0%), by the wholesale intermediation activities (+7.6%) and by the wholesale of household goods, other than food (+0.3%). Drops were registered by the wholesale of information and communication equipment (-18.5%), by the wholesale of other machinery, equipment and supplies (-0.6%) and by the wholesale of food, beverages and tobacco (-0.1%).

As against the previous month, in July 2017 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, adjusted series according to the number of working days and to seasonality, in nominal terms, globally increased by 1.6% due to the increases registered by the wholesale of agricultural raw materials and live animals (+33.6%), by the wholesale of information and communication equipment (+5.0%), by the non-specialised wholesale (+3.6%), by the other specialised wholesale (+2.6%), by the wholesale intermediation activities (+1.8%) and by the wholesale of household goods, other than food (+0.2%). Drops were registered by the wholesale of food, beverages and tobacco (-1.9%) and by the wholesale of other machinery, equipment and supplies (-0.4%).

July 2017 as against July 2016

As against July 2016, in July 2017 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, gross series, in nominal terms, registered an increase of 7.6% due to the increases registered by the other specialised wholesale (+17.7%), by the non-specialised wholesale (+17.3%), by the wholesale of agricultural raw materials and live animals (+12.2%), by the wholesale of household goods, other than food (+7.1%) and by the wholesale intermediation activities (+6.9%). Drops were registered by the wholesale of information and

communication equipment (-5.6%), by the wholesale of other machinery, equipment and supplies (-1.1%) and by the wholesale of food, beverages and tobacco (-0.4%).

As against July 2016, in July 2017 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, adjusted series according to the number of working days and to seasonality, in nominal terms, registered an increase of 6.2% due to the increases registered by the other specialised wholesale (+18.4%), by the non-specialised wholesale (+15.1%), by the wholesale of household goods, other than food (+5.5%), by the wholesale intermediation activities (+4.0%), by the wholesale of agricultural raw materials and live animals (+3.9%) and by the wholesale of food, beverages and tobacco (+0.3%). Drops were registered by the wholesale of information and communication equipment (-4.6%) and by the wholesale of other machinery, equipment and supplies (-2.4%).

Period 1.I-31.VII.2017 as against period 1.I-31.VII.2016

As against period 1.I-31.VII.2016, in the period 1.I-31.VII.2017 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, gross series, in nominal terms, registered an increase of 6.5% due to the increases registered by the other specialised wholesale (+14.2%), by the non-specialised wholesale (+11.5%), by the wholesale of food, beverages and tobacco (+6.6%), by the wholesale of household goods, other than food (+5.3%), by the wholesale of other machinery, equipment and supplies (+3.7%) and by the wholesale intermediation activities (+0.4%). Drops were registered by the wholesale of agricultural raw materials and live animals (-1.9%) and by the wholesale of information and communication equipment (-1.5%).

As against period 1.I-31.VII.2016, in the period 1.I-31.VII.2017 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, adjusted series according to the number of working days and to seasonality, in nominal terms, registered an increase of 7.0% due to the increases registered by the other specialised wholesale (+13.0%), by the non-specialised wholesale (+11.3%), by the wholesale of other machinery, equipment and supplies (+8.9%), by the wholesale of food, beverages and tobacco (+6.8%), by the wholesale of household goods, other than food (+5.6%), by the wholesale intermediation activities (+1.1%) and by the wholesale of agricultural raw materials and live animals (+0.3%). The wholesale of information and communication equipment decreased by 3.5%.

Additional information:

- ✓ The turnover represents the total revenue recorded by the company during the reporting period, obtained from both the main activity and the secondary activities performed by them. The turnover does not include VAT and the revenue from the sale or transfer of assets.
- ✓ The turnover volume indices of the retail are Laspeyres type indices. The first indices obtained are at the level of CANE Rev. 2 group, then, by aggregations, indices at total level are obtained. The weights used for aggregation are calculated based on the turnover according to the results of the Business Structural Survey from the reference year (2010).
