The wholesale turnover in October 2018

- As against the previous month, in October 2018 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, in nominal terms, increased both as gross series by **4.9%** and as adjusted series according to the number of working days and to seasonality by **2.6%**.
- As against the corresponding month of the previous year, **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, in nominal terms, increased both as gross series by **12.8%** and as adjusted series according to the number of working days and to seasonality by **9.6%**.
- As against the period 1.I-31.X.2017, in the period 1.I-31.X.2018 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, in nominal terms, increased both as gross series by **9.3%** and as adjusted series according to the number of working days and to seasonality and by **8.9%**.

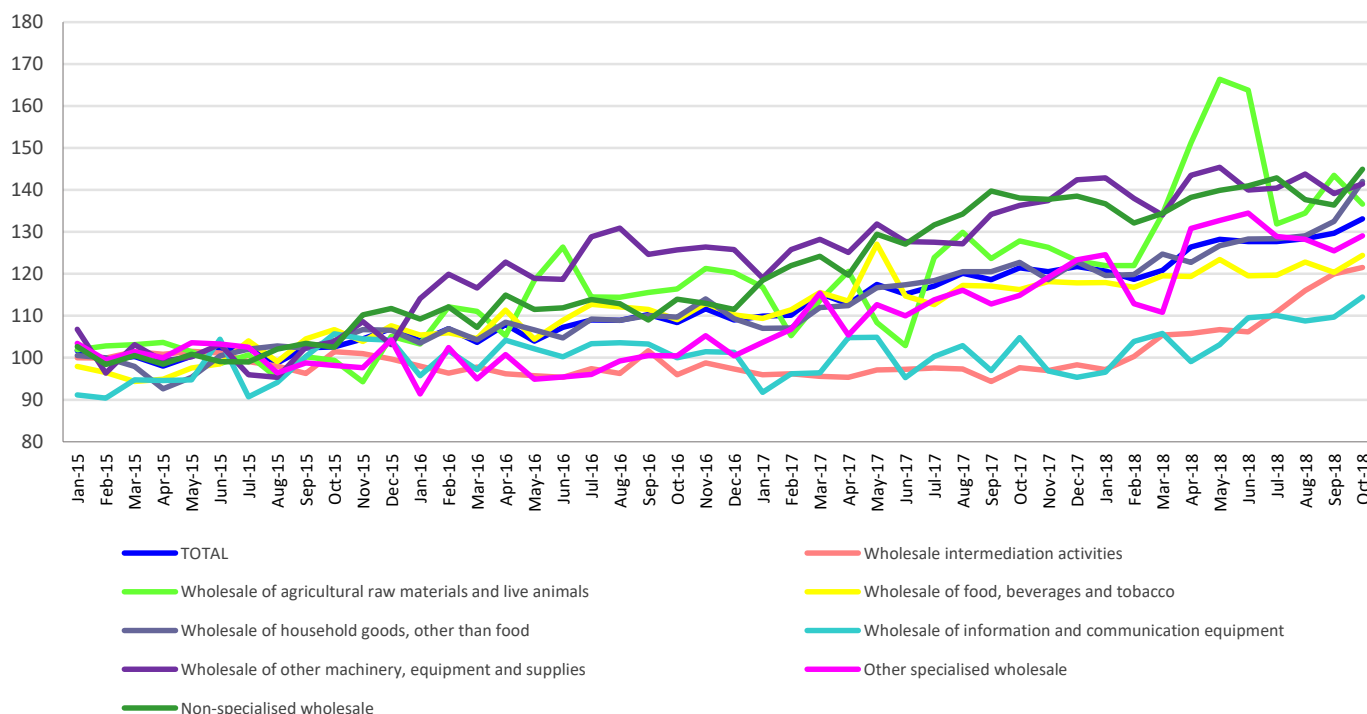

October 2018 as against September 2018

As against the previous month, in October 2018 the **wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, gross series, in nominal terms, globally increased by 4.9% due to the increases registered by the wholesale of information and communication equipment (+25.6%), by the wholesale of household goods, other than food (+15.4%), by the non-specialised wholesale (+14.6%), by the wholesale of other machinery, equipment and supplies (+7.5%), by the wholesale intermediation activities (+5.6%), by the other specialised wholesale (+3.7%) and by the wholesale of food, beverages and tobacco (+2.7%). The wholesale of agricultural raw materials and live animals decreased by 15.6%.

As against the previous month, in October 2018 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, adjusted series according to the number of working days and to seasonality, in nominal terms, globally increased by 2.6% due to the increases registered by the wholesale of household goods, other than food (+7.1%), by the non-specialised wholesale (+6.3%), by the wholesale of information and communication equipment (+4.4%), by the wholesale of food, beverages and tobacco (+3.4%), by the other specialised wholesale (+2.9%), by the wholesale of other machinery, equipment and supplies (+1.7%) and by the wholesale intermediation activities (+1.3%). The wholesale of agricultural raw materials and live animals decreased by 4.8%.

October 2018 as against October 2017

As against October 2017, in October 2018 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, gross series, in nominal terms, registered an increase of 12.8% due to the rises registered by the wholesale intermediation activities (+28.1%), by the wholesale of household goods, other than food (+19.2%), by the other specialised wholesale (+14.7%), by the wholesale of information and communication equipment (+11.7%), by the non-specialised wholesale (+11.0%), by the wholesale of food, beverages and tobacco (+8.4%), by the wholesale

of other machinery, equipment and supplies (+6.8%) and by the wholesale of agricultural raw materials and live animals (+5.8%).

As against October 2017, in October 2018 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, adjusted series according to the number of working days and to seasonality, in nominal terms, registered an increase of 9.6% due to the rises registered by the wholesale intermediation activities (+24.5%), by the wholesale of household goods, other than food (+15.7%), by the other specialised wholesale (+12.4%), by the wholesale of information and communication equipment (+9.3%), by the wholesale of food, beverages and tobacco (+7.1%), by the wholesale of agricultural raw materials and live animals (+6.9%), by the non-specialised wholesale (+4.9%) and by the wholesale of other machinery, equipment and supplies (+3.7%).

Period 1.I-31.X.2018 as against period 1.I-31.X.2017

As against period 1.I-31.X.2017, in the period 1.I-31.X.2018 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, gross series, in nominal terms, registered an increase of 9.3% due to the rises registered by the wholesale intermediation activities (+16.1%), by the wholesale of agricultural raw materials and live animals (+14.0%), by the other specialised wholesale (+12.5%), by the wholesale of household goods, other than food (+10.2%), by the wholesale of other machinery, equipment and supplies (+8.5%), by the non-specialised wholesale (+6.3%), by the wholesale of information and communication equipment (+6.0%) and by the wholesale of food, beverages and tobacco (+4.1%).

As against period 1.I-31.X.2017, in the period 1.I-31.X.2018 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, adjusted series according to the number of working days and to seasonality, in nominal terms, registered an increase of 8.9% due to the rises registered by the wholesale of agricultural raw materials and live animals (+19.9%), by the other specialised wholesale (+13.2%), by the wholesale intermediation activities (+13.0%), by the wholesale of household goods, other than food (+10.3%), by the wholesale of other machinery, equipment and supplies (+9.8%), by the non-specialised wholesale (+7.7%), by the wholesale of information and communication equipment (+6.7%) and by the wholesale of food, beverages and tobacco (+4.2%).

Additional information:

- ✓ **IMPORTANT!** In order to highlight the changes in the economy structure, starting with the data release for **January 2018** reference month, the base year used for the calculation of the indices, for all short-term indicators, was changed from 2010 to 2015.
- ✓ The changing of the base year involves the updating of the weighting system, to reflect the structural modifications occurred in the national economy activities. These modifications determined the proper recalculation and revision of the data series previously published.
- ✓ These changes will appear in press releases, statistical publications published by the INS and in the TEMPO online database.
- ✓ The turnover represents the total revenue recorded by the company during the reporting period, obtained from both the main activity and the secondary activities performed by them. The turnover does not include VAT and the revenue from the sale or transfer of assets.
- ✓ The turnover volume indices of the retail are Laspeyres type indices. The first indices obtained are at the level of CANE Rev. 2 group, then, by aggregations, indices at total level are obtained. The weights used for aggregation are calculated based on the turnover according to the results of the Business Structural Survey from the reference year (2015).
