# THE WHOLESALE TURNOVER INCREASED IN THE PERIOD 1.I-30.XI.2015 BY 3.4%

- As against the previous month, in November 2015 the wholesale turnover (excluding the trade with motor vehicles and motorcycles), in nominal terms, decreased as gross series by 5.5% and increased as adjusted series according to the number of working days and to seasonality by 0.6%.
- As against the corresponding month of the previous year, the wholesale turnover (excluding the trade with motor vehicles and motorcycles), in nominal terms, increased both as gross series by 6.8% and as adjusted series according to the number of working days and to seasonality by 6.5%.
- As against the period 1.I-30.XI.2014, in the period 1.I-30.XI.2015 the wholesale turnover (excluding the trade with motor vehicles and motorcycles), in nominal terms, increased both as gross series and as adjusted series according to the number of working days and to seasonality by 3.4% and by 3.3%, respectively.

### November 2015 as against October 2015

As against the previous month, in November 2015 the **wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, gross series, in nominal terms, globally decreased by 5.5% due to the drops registered by the wholesale of agricultural raw materials and live animals (-29.0%), by the other specialised wholesale (-12.1%), by the wholesale of food, beverages and tobacco (-4.6%) and by the wholesale intermediation activities (-1.7%). Increases were registered by the wholesale of information and communication equipment (+14.9%), by the wholesale of other machinery, equipment and supplies (+5.3%), by the non-specialised wholesale (+3.2%) and by the wholesale of household goods, other than food (+0.6%).

As against the previous month, in November 2015 the wholesale turnover (excluding the trade with motor vehicles and motorcycles), adjusted series according to the number of working days and to seasonality, in nominal terms, globally increased by 0.6% due to the increments registered by the wholesale intermediation activities (+3.7%), by the non-specialised wholesale (+3.4%), by the wholesale of other machinery, equipment and supplies (3.2%), by the other specialised wholesale (+1.5%) and by the wholesale of household goods, other than food (+0.7%).

Decreases were registered by the wholesale of agricultural raw materials and live animals (-7.2%), by the wholesale of food, beverages and tobacco (-1.5%) and by the wholesale of information and communication equipment (-0.7%).

## November 2015 as against November 2014

As against November 2014, in November 2015 the wholesale turnover (excluding the trade with motor vehicles and motorcycles), gross series, in nominal terms, registered an increase of 6.8% due to the increments registered by the wholesale of information and communication equipment (+23.5%), by the non-specialised wholesale (+21.1%), by the wholesale of food, beverages and tobacco (+11.3%), by the wholesale intermediation activities (+7.4%), by the wholesale of household goods, other than food (+3.3%), by the other specialised wholesale (+2.2%) and by the wholesale of other machinery, equipment and supplies (+1.7%). The wholesale of agricultural raw materials and live animals decreased by 5.2%.

As against November 2014, in November 2015 the wholesale turnover (excluding the trade with motor vehicles and motorcycles), adjusted series according to the number of working days and to seasonality, in nominal terms, registered an increase of 6.5% due to the increments registered by the wholesale of information and communication equipment (+15.5%), by the non-specialised wholesale (+14.7%), by the wholesale of food, beverages and tobacco (+10.8%), by the wholesale intermediation activities (+4.2%), by the other specialised wholesale (+3.6%) and by the wholesale of household goods, other than food (+2.2%). Drops were registered by the wholesale of other machinery, equipment and supplies (-5.5%) and by the wholesale of agricultural raw materials and live animals (-0.1%).

# Period 1.I-30.XI.2015 as against period 1.I-30.XI.2014

As against the period 1.I-30.XI.2014, in the period 1.I-30.XI.2015 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, gross series, in nominal terms, registered an increase of 3.4% due to the increments registered by the wholesale of information and communication equipment (+15.7%), by the non-specialised wholesale (+12.4%), by the wholesale of agricultural raw materials and live animals (+12.0%), by the wholesale of food, beverages and tobacco (+5.8%) and by the other specialised wholesale (+0.6%). Drops were registered by the wholesale of other machinery, equipment and supplies (-6.6%), by the wholesale intermediation activities (-1.8%) and by the wholesale of household goods, other than food (-1.2%).

As against the period 1.I-30.XI.2014, in the period 1.I-30.XI.2015 the wholesale turnover (excluding the trade with motor vehicles and motorcycles), adjusted series according to the number of working days and to seasonality, in nominal terms, registered an increase of 3.3% due to the increments registered by the wholesale of information and communication equipment (+12.2%), by the wholesale of agricultural raw materials and live animals (+11.8%), by the non-specialised wholesale (+9.8%), by the wholesale of food, beverages and tobacco (+5.4%) and by the other specialised wholesale (+1.0%). Drops were registered by the wholesale of other machinery, equipment and supplies (-4.3%), by the wholesale of household goods, other than food (-1.3%) and by the wholesale intermediation activities (-0.3%).
