

Domain: Trade - services

In November 2016, the wholesale turnover increased by 10.7% compared to November 2015

- As against the previous month, in November 2016 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, in nominal terms, increased both as gross series by **0.3%** and as adjusted series according to the number of working days and to seasonality by **1.6%**.
- As against the corresponding month of the previous year, **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, in nominal terms, increased both as gross series by **10.7%** and as adjusted series according to the number of working days and to seasonality by **7.5%**.
- As against the period 1.I-30.XI.2015, in the period 1.I-30.XI.2016 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, in nominal terms, increased both as gross series and as adjusted series according to the number of working days and to seasonality by **8.1%** and by **7.3%**, respectively.

-2010=100 -

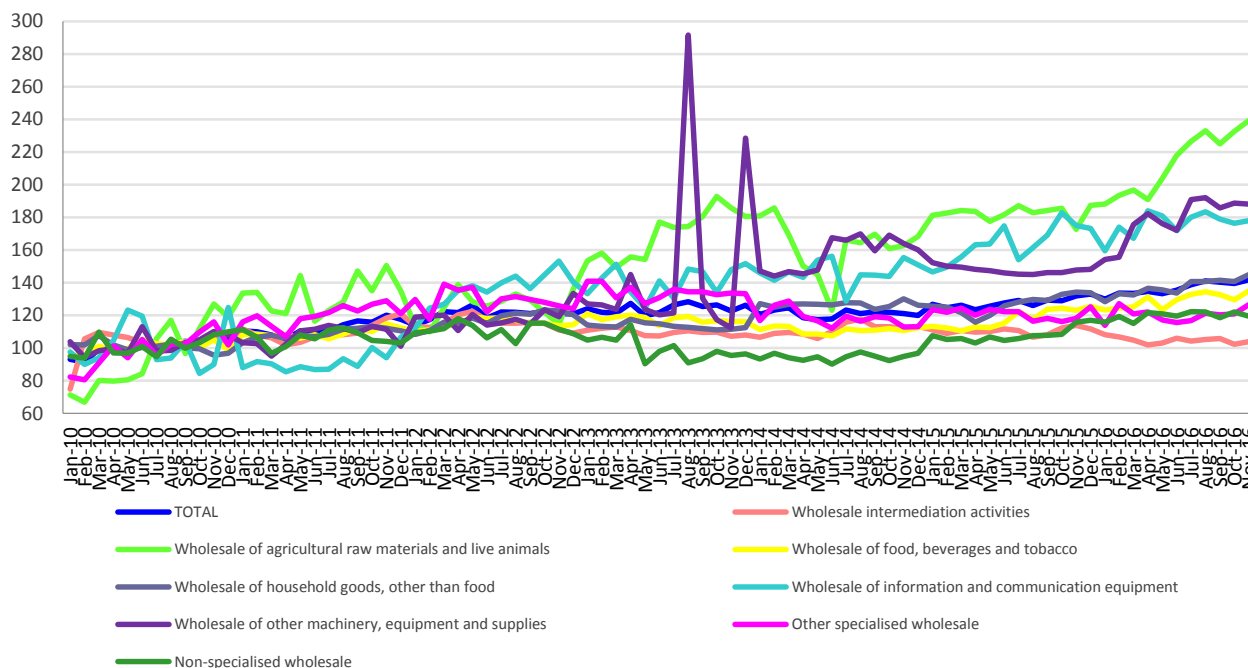

November 2016 as against October 2016

As against the previous month, in November 2016 the **wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, gross series, in nominal terms, globally increased by 0.3% due to the increments registered by the wholesale of information and communication equipment (+14.4%), by the wholesale intermediation activities (+5.7%), by the wholesale of household goods, other than food (+5.5%), by the wholesale of food, beverages and tobacco (+4.6%), by the wholesale of other machinery, equipment and supplies (+3.3%) and by the non-specialised wholesale (+0.4%). Drops were registered by the wholesale of agricultural raw materials and live animals (-18.0%) and by the other specialised wholesale (-4.5%).

As against the previous month, in November 2016 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, adjusted series according to the number of working days and to seasonality, in nominal terms, globally increased by 1.6% due to the increments registered by the other specialised wholesale (+4.5%), by the wholesale of food, beverages and tobacco (+4.1%), by the wholesale of household goods, other than food (+2.8%), by the wholesale of agricultural raw materials and live animals (+2.8%), by the wholesale intermediation activities (+1.4%) and by the wholesale of information and communication equipment (+0.9%). Drops were registered by the non-specialised wholesale (-2.0%) and by the wholesale of other machinery, equipment and supplies (-0.3%).

November 2016 as against November 2015

As against November 2015, in November 2016 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, gross series, in nominal terms, registered an increase of 10.7% due to the increments registered by the wholesale of agricultural raw materials and live animals (+43.0%), by the wholesale of other machinery, equipment and supplies (+21.4%), by the wholesale of food, beverages and tobacco (+11.4%), by the other specialised wholesale (+10.0%), by the wholesale of household goods, other than food (+8.2%) and by the non-specialised wholesale (+5.2%). Drops were registered by the wholesale intermediation activities (-4.4%) and by the wholesale of information and communication equipment (-3.6%).

As against November 2015, in November 2016 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, adjusted series according to the number of working days and to seasonality, in nominal terms, registered an increase of 7.5% due to the increments registered by the wholesale of agricultural raw materials and live animals (+38.6%), by the wholesale of other machinery, equipment and supplies (+27.3%), by the wholesale of food, beverages and tobacco (+9.6%), by the wholesale of household goods, other than food (+7.8%), by the other specialised wholesale (+6.9%), by the non-specialised wholesale (+3.1%) and by the wholesale of information and communication equipment (+1.7%). Drops were registered by the wholesale intermediation activities (-8.9%).

Period 1.I-30.XI.2016 as against period 1.I-30.XI.2015

As against the period 1.I-30.XI.2015, in the period 1.I-30.XI.2016 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, gross series, in nominal terms, registered an increase of 8.1% due to the increments registered by the wholesale of other machinery, equipment and supplies (+25.7%), by the wholesale of agricultural raw materials and live animals (+19.2%), by the non-specialised wholesale (+12.2%), by the wholesale of food, beverages and tobacco (+10.9%), by the wholesale of household goods, other than food (+8.9%) and by the wholesale of information and communication equipment (+5.6%). Drops were registered by the wholesale intermediation activities (-4.6%) and by the other specialised wholesale (-0.2%).

As against the period 1.I-30.XI.2015, in the period 1.I-30.XI.2016 **the wholesale turnover (excluding the trade with motor vehicles and motorcycles)**, adjusted series according to the number of working days and to seasonality, in nominal terms, registered an increase of 7.3% due to the increments registered by the wholesale of other machinery, equipment and supplies (+20.8%), by the wholesale of agricultural raw materials and live animals (+17.2%), by the non-specialised wholesale (+11.7%), by the wholesale of food, beverages and tobacco (+10.4%), by the wholesale of household goods, other than food (+8.6%) and by the wholesale of information and communication equipment (+7.7%). Drops were registered by the wholesale intermediation activities (-5.1%) and by the other specialised wholesale (-0.3%).
