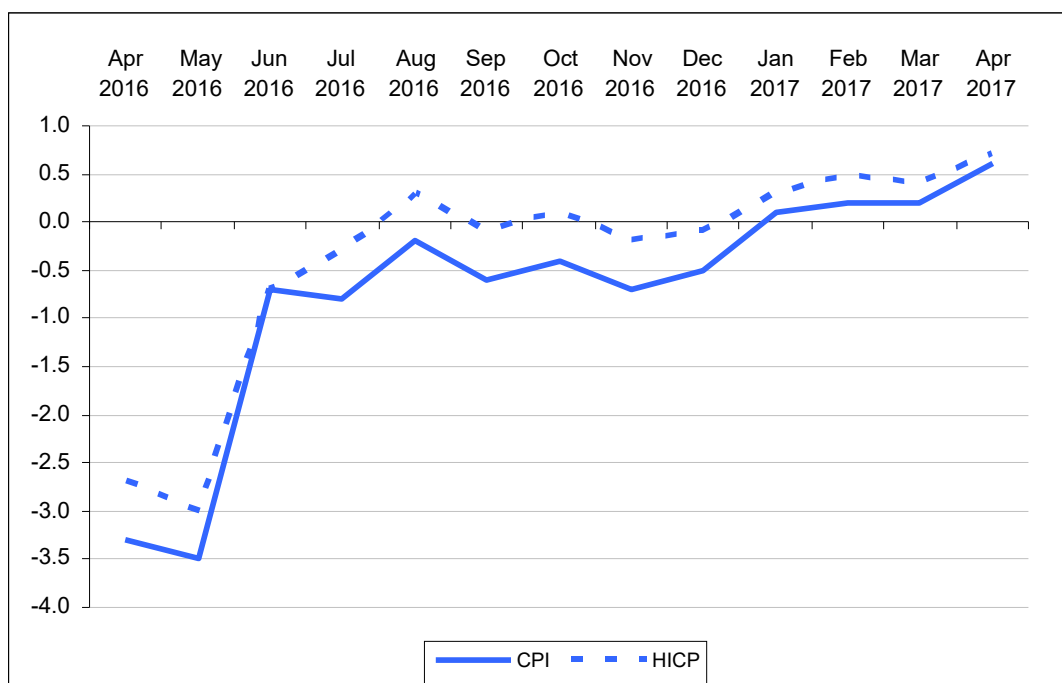

Domain: Consumer prices

IN APRIL 2017, THE ANNUAL RATE OF PRICES WAS 0.6%

- Consumer prices were up 0.6% in April 2017 compared to April 2016.
- The average rate of consumer prices based on the CPI over the last 12 months (May 2016-April 2017) as compared to the previous 12 months (May 2015-April 2016) was -0.5%. The average rate based on the HICP was -0.2%.
