### **INFLATION AND THE EVOLUTION OF CONSUMER PRICES: JULY 2025**


# 1. The Consumer Price Index (CPI) – indicator for determining inflation at national level

- The Consumer Price Index in July 2025 compared to June 2025 is 102.68%.
- The inflation rate since the beginning of the year (July 2025 compared to December 2024) is 5.8%.
- The annual inflation rate in July 2025 compared to July 2024 is 7.8%.
- The average rate of change in consumer prices over the last 12 months (August 2024-July 2025) as compared to the previous 12 months (August 2023-July 2024) is 5.3%.

# 2. The Harmonised Index of Consumer Prices (HICP) – indicator for determining inflation across the EU

- The Harmonised Index of Consumer Prices in July 2025 compared to June 2025 is 101.35%.
- The HICP-based annual inflation rate in July 2025 compared to July 2024 is 6.6%.
- The HICP-based average rate of change in consumer prices over the last 12 months (August 2024-July2025) as compared to the previous 12 months (August 2023-July 2024) is 5.4%.
