## INFLATION AND THE EVOLUTION OF CONSUMER PRICES: SEPTEMBER 2021

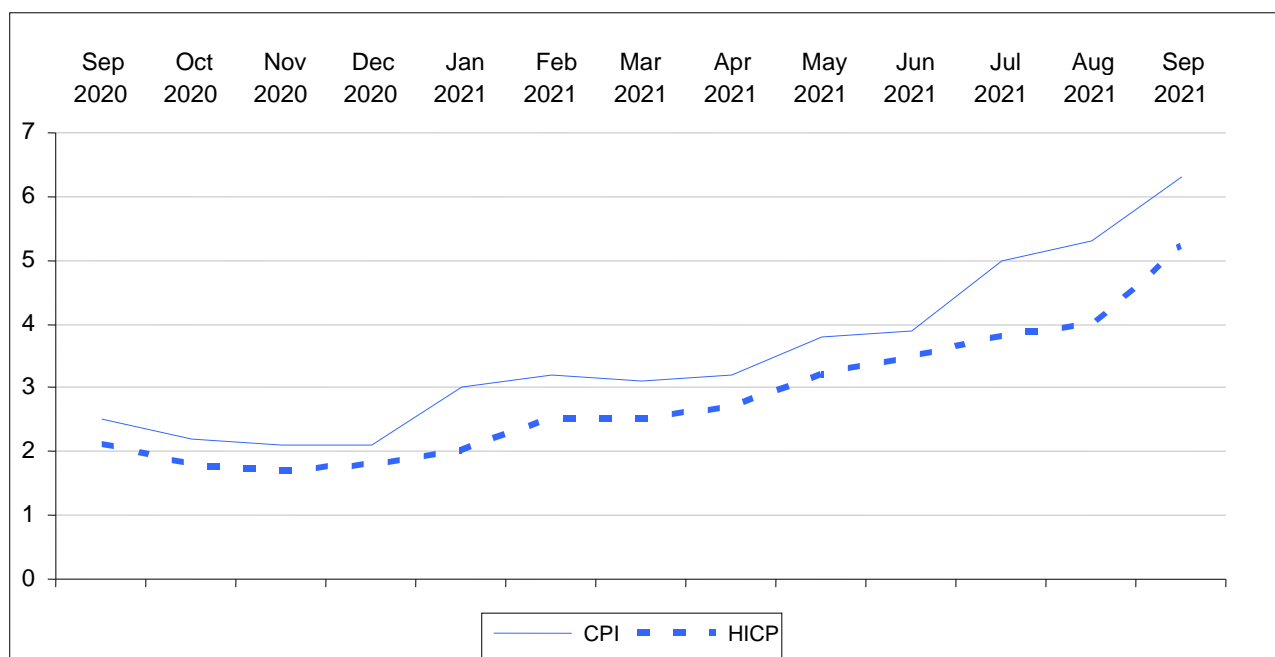
### 1. The Consumer Price Index (CPI) – inflation indicator at national level

- Consumer prices were up 0.8% in September 2021 from August 2021.
- The inflation rate since the beginning of the year (September 2021 compared to December 2020) is 5.6%.
- The annual inflation rate in September 2021 compared to September 2020 is 6.3%.
- The average consumer price rate over the last 12 months (October 2020-September 2021) as compared to the previous 12 months (October 2019-September 2020) is 3.6%.

### 2. The Harmonised Index of Consumer Prices (HICP) – inflation indicator for EU Member States

- The Harmonised Index of Consumer Prices in September 2021 compared to August 2021 is 100.83%.
- The HICP-based annual inflation rate in September 2021 compared to September 2020 is 5.2%.
- The HICP-based average consumer price rate over the last 12 months (October 2020-September 2021) as compared to the previous 12 months (October 2019-September 2020) is 2.9%.
