INFLATION AND THE EVOLUTION OF CONSUMER PRICES: SEPTEMBER 2024


1. The Consumer Price Index (CPI) – indicator for determining inflation at national level

- The Consumer Price Index in September 2024 compared to August 2024 is 100.33%.
- The inflation rate since the beginning of the year (September 2024 compared to December 2023) is 3.8%.
- The annual inflation rate in September 2024 compared to September 2023 is 4.6%.
- The average rate of change in consumer prices over the last 12 months (October 2023-September 2024) as compared to the previous 12 months (October 2022-September 2023) is 6.1%.

2. The Harmonised Index of Consumer Prices (HICP) – indicator for determining inflation across the EU

- The Harmonised Index of Consumer Prices in September 2024 compared to August 2024 is 100.40%.
- The HICP-based annual inflation rate in September 2024 compared to September 2023 is 4.8%.
- The HICP-based average rate of change in consumer prices over the last 12 months (October 2023-September 2024) as compared to the previous 12 months (October 2022-September 2023) is 6.4%.
