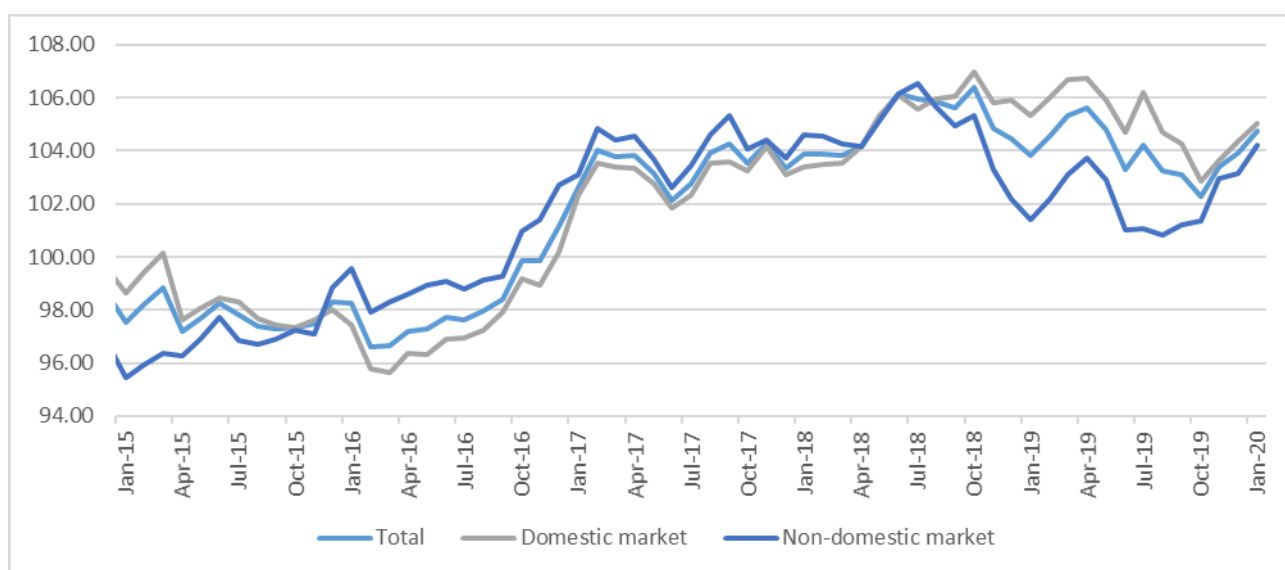


Domain: Industrial production prices

THE EVOLUTION OF INDUSTRIAL PRODUCTION PRICES IN JANUARY 2020

- In **January 2020**, industrial production prices for the total (domestic market and non-domestic market) were up 1.4% from **December 2019**.
- Industrial production prices for the total (domestic market and non-domestic market) increased by 4.7% in **January 2020** compared to **January 2019**.
