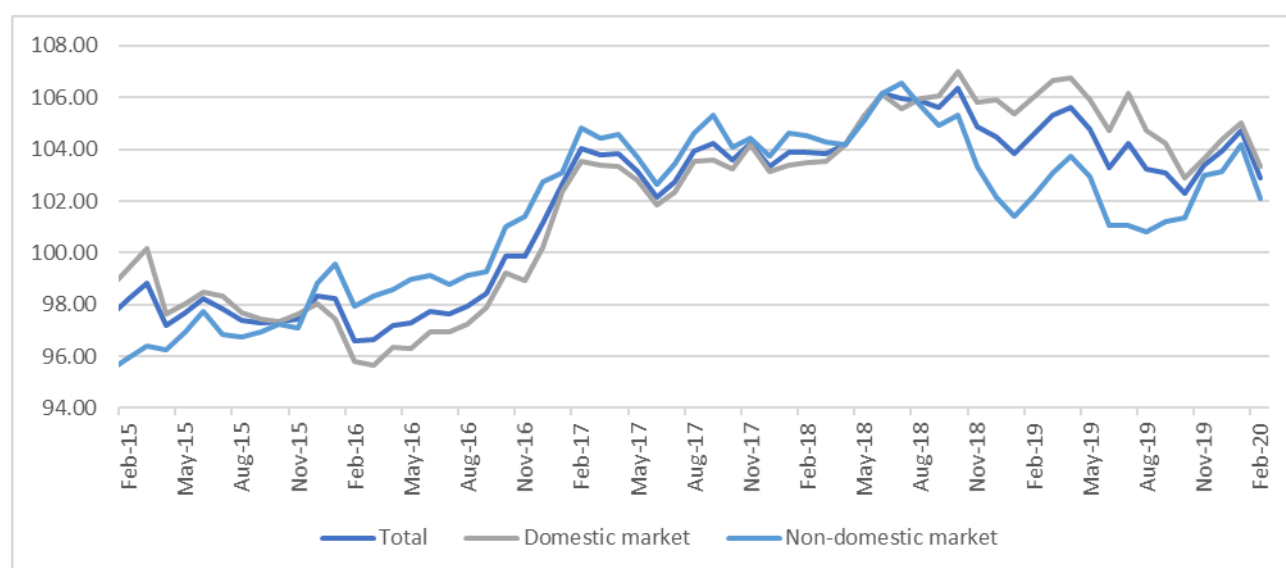


Domain: Industrial production prices

THE EVOLUTION OF INDUSTRIAL PRODUCTION PRICES IN FEBRUARY 2020

- In **February 2020**, industrial production prices for the total (domestic market and non-domestic market) were down 0.9% from **January 2020**.
- Industrial production prices for the total (domestic market and non-domestic market) increased by 2.9% in **February 2020** compared to **February 2019**.
