

THE EVOLUTION OF INDUSTRIAL PRODUCTION PRICES IN APRIL 2019

- In **April 2019**, industrial production prices for the total (domestic market and non-domestic market) were up 0.6% from **March 2019**.
- Industrial production prices for the total (domestic market and non-domestic market) increased by 5.6% in April 2019 compared to April 2018.
