

THE EVOLUTION OF INDUSTRIAL PRODUCTION PRICES IN MAY 2020

- In May 2020, industrial production prices for the total (domestic market and non-domestic market) were down 0.3% from April 2020.
- Industrial production prices for the total (domestic market and non-domestic market) decreased by 2.0% in May 2020 compared to May 2019.
