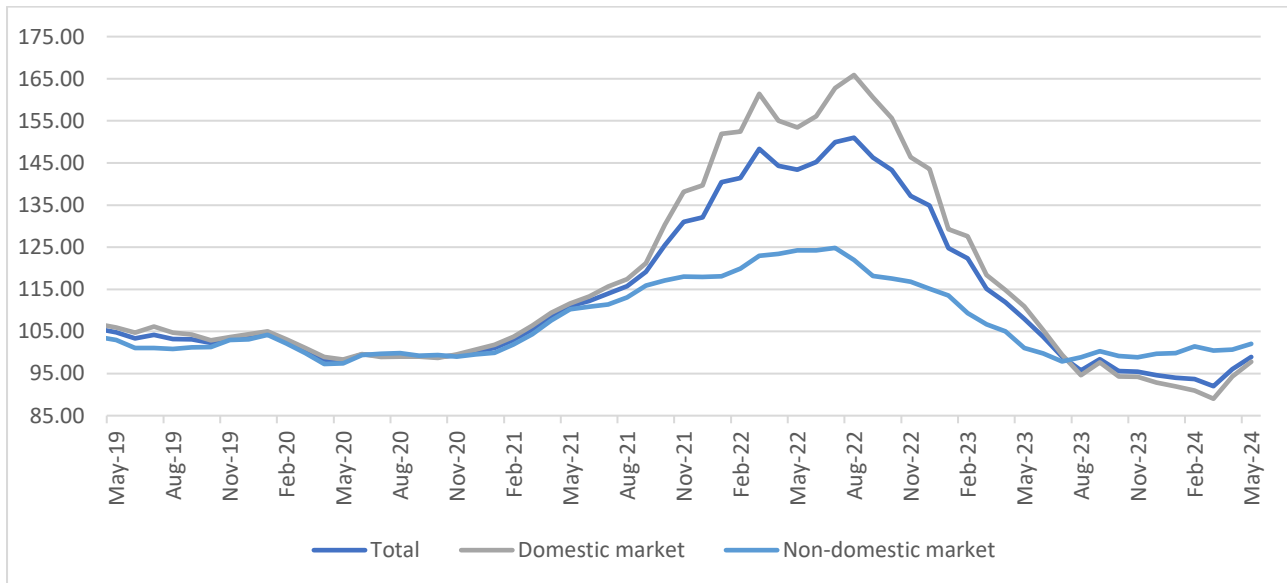


Domain: Industrial production prices

THE EVOLUTION OF INDUSTRIAL PRODUCTION PRICES IN MAY 2024

- In **May 2024**, industrial production prices for the total (domestic market and non-domestic market) increased by 0.7% compared to **April 2024**.
- Industrial production prices for the total (domestic market and non-domestic market) fell by 1.0% in **May 2024** compared to **May 2023**.
