


Domain: Industrial production prices

THE EVOLUTION OF INDUSTRIAL PRODUCTION PRICES IN JUNE 2020

- In **June 2020**, industrial production prices for the total (domestic market and non-domestic market) were up 0.8% from **May 2020**.
- Industrial production prices for the total (domestic market and non-domestic market) decreased by 0.5% in June 2020 compared to June 2019.
