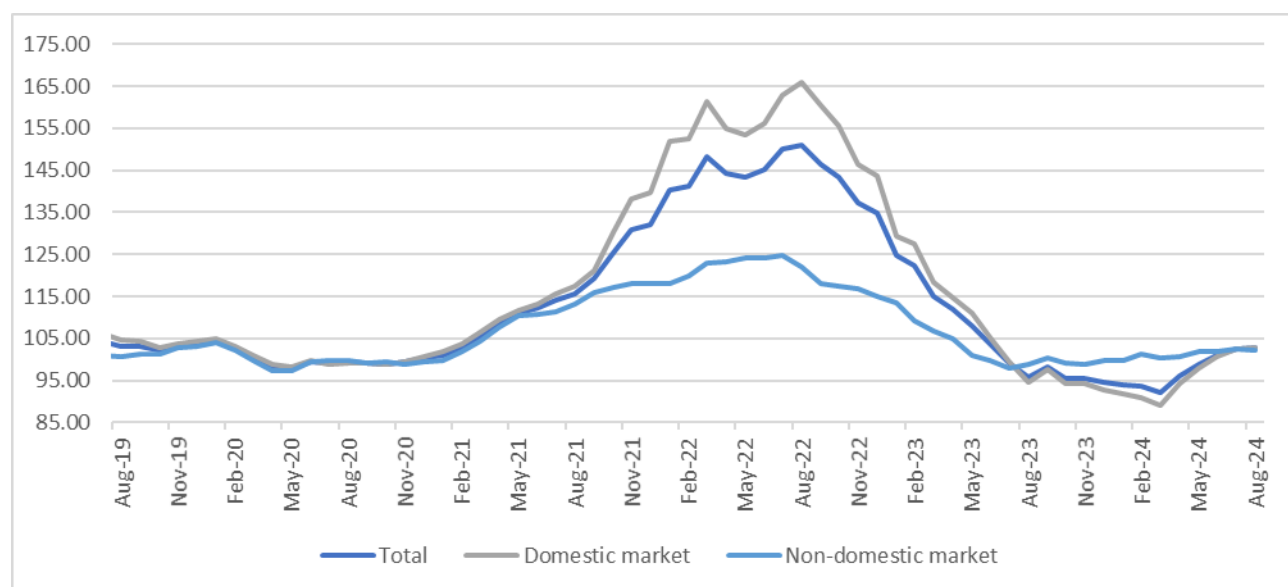


Domain: Industrial production prices

THE EVOLUTION OF INDUSTRIAL PRODUCTION PRICES IN AUGUST 2024

- In **August 2024**, industrial production prices for the total (domestic market and non-domestic market) decreased by 1.1% compared to **July 2024**.
- Industrial production prices for the total (domestic market and non-domestic market) rose by 2.7% in **August 2024** compared to **August 2023**.
