

Domain: Industrial production prices

INDUSTRIAL PRODUCTION PRICES UP 0.3%

- In **September 2017**, industrial production prices for the total (domestic market and non-domestic market) were up 0.3% from **August 2017**.
- Industrial production prices for the total (domestic market and non-domestic market) increased by 4.3% in **September 2017** compared to **September 2016**.
