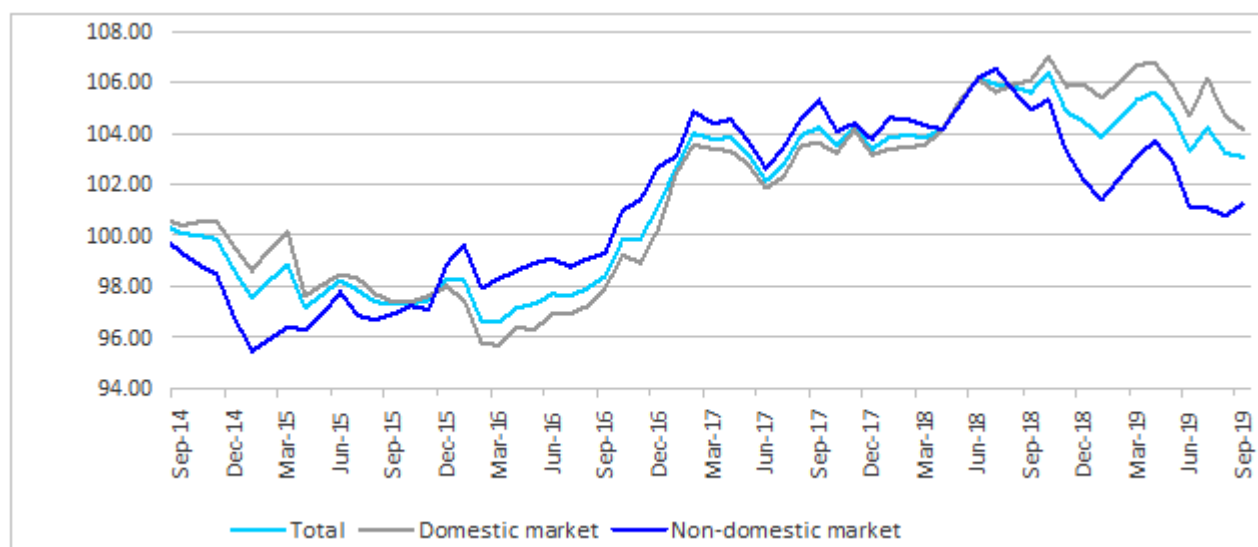


Domain: Industrial production prices

THE EVOLUTION OF INDUSTRIAL PRODUCTION PRICES IN SEPTEMBER 2019

- In **September 2019**, industrial production prices for the total (domestic market and non-domestic market) were up 0.1% from **August 2019**.
- Industrial production prices for the total (domestic market and non-domestic market) increased by 3.1% in **September 2019** compared to **September 2018**.
