


Domain: Industrial production prices

THE EVOLUTION OF INDUSTRIAL PRODUCTION PRICES IN NOVEMBER 2019

- In **November 2019**, industrial production prices for the total (domestic market and non-domestic market) were up 0.3% from **October 2019**.
- Industrial production prices for the total (domestic market and non-domestic market) increased by 3.4% in **November 2019** compared to **November 2018**.
