

## THE EVOLUTION OF INDUSTRIAL PRODUCTION PRICES IN DECEMBER 2019

- In **December 2019**, industrial production prices for the total (domestic market and non-domestic market) were up 0.3% from **November 2019**.
- Industrial production prices for the total (domestic market and non-domestic market) increased by 3.9% in **December 2019** compared to **December 2018**.
